Whereas, Sh. Vikram Singh, TGT(NM) who is presently working in GMS Pat u/c GSSS Kashapat Distt. Shimla has filed CWP No. 6186/2020 tiled as Vikram Singh Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Pat u/c GSSS Kashapat Distt. Shimla to a soft area after completion of normal tenure. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 23.12.2020, when after hearing the matter the Hon'ble High Court has directed as under:-


"Consequently, this petition is disposed of with liberty to the petitioner to make a fresh representation to the respondent/authorities concerned giving five stations of his choice, which must be spread in more than one district, within one week from today, in the light of clause 16.1 read with clause 16.5 of the transfer policy. On receipt of such representation, the respondent/authorities shall decide the representation of the petitioner, in the light of the transfer policy occupying the field, within two weeks. It is clarified that while deciding the representation of the petitioner the respondents shall consider the stations of choice of the petitioner as mentioned in his representation, subject to the condition that the incumbents posted there have completed their normal tenure of posting; in accordance with the transfer policy. In case none of them have completed the normal tenure then the office of the respondent/authorities shall get in touch with the petitioner apprising him of vacant stations where the incumbents have completed their normal tenure and the possible places where the petitioner can be posted. Pending application(s), if any, are closed."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 05.02.2021 and requested that he may kindly be transferred from GMS Pat u/c GSSS Kashapat Distt. Shimla to GMS Kitpal u/c GSSS Sera or GHS Sathwin u/c GSSS Maharal GSSS Jahu GHS Manjheli or GMS Ghaloon u/c GSSS Jalari distt. Hamirpur.

On the perusal of the record, it is found that the petitioner is working in GMS Pat u/c GSSS Kashapat Distt. Shimla since 07.08.2017 and he has completed his normal tenure at his present place of posting. GMS Pat u/c GSSS Kashapat Distt. Shimla falls in Hard Area.

The petitioner has requested for adjustment in GMS Kitpal u/c GSSS Sera Distt Hamirpur against longer stayee. After verifying the facts it has been noticed that Sh. Sanjeev Kumar TGT (NM) is working in GMS Kitpal u/c GSSS Sera Distt Hamirpur since 23.08.2006 as PTA and regularized on 20.08.2020.

Hence, petitioner is hereby adjusted in GMS Kitpal u/c GSSS Sera Distt Hamirpur vice longer stayee i.e. Sh. Sanjeev Kumar TGT (NM) on vice-versa basis with TTA/JT. The representation of the petitioner is disposed of accordingly.
