State of H.P. before the Hon'ble High Court of H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 01.01.20212 when after hearing the matter the Hon'ble High Court has directed as under:-

"Consequently, the present petition is allowed and the impugned office order dated 28.10.2020 (Annexure P/1) is quashed and set aside. However, respondent No.3 is also permitted to make a representation and in case the same is made within two weeks from today, respondents No.1 and 2 shall consider and decide the same within a period of four weeks thereafter. Pending application(s), if any, also stands disposed of."

The department has received representation of Smt. Rajni Bala TGT (NM) respondent No. 3 on 3.1.2021 wherein the concerned teacher has requested that she may kindly be retained in GSSS Badoli (Una) aganst Sh. Harish Kumar TGT (NM). Since, transfer order issued by the department on 28.10.2020 on vice versa basis has already been quashed/set aside by the Hon'ble High Court hence, her request cannot be acceded to being not tenable.

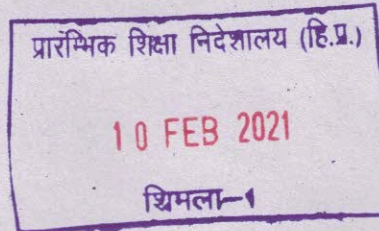

Whereas, Anuj Sharma, TGT (NM) who is u/t from GSSS Millah Distt. Sirmour to GSSS Kolar Distt. Sirmour has filed CWP No. 5991/2020 titled as Anuj Sharma, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer/adjustment in Distt.Kangra and Distt. Una.The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 18.12.2020, when after hearing the matter the Hon'ble High Court has directed as under:-

" The writ petition is disposed of with a direction to the respondent concerned to decide the representation(s), of, the petitioner, Annexure P-3 and Annexure P-5, in accordance with law, within four weeks, and, after affording an opportunity of hearing to him. It is made clear that the impugned transfer order, of, 14.12.2020, shall remain stayed, till the representation of the petitioner, is, decided by the competent authority. Also, the pending application(s), if any, are also disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner attended personal hearing on 05.02.2021. The petitioner requested that she may kindly be adjusted in Distt.Kangra and Una against vacancy which will accrue due to promotion of TGTs to the cadre of PGTs. Since, presently promotion list has not been issued by the Director of Higher Education hence, request for transfer in Distt. Kangra/Una cannot be acceded to at this stage.

The representation of the applicant is disposed of accordingly.

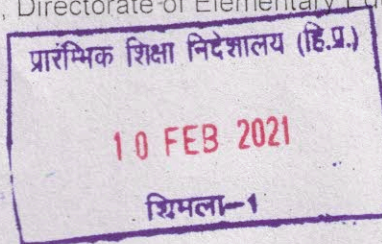
