In the matter of: CWP. No. 699/2021-titled as Dimple Kumari, TGT (NM) Vs. State of H.P. & Others.

Whereas, Dimple Kumari, TGT (NM) who is u/t from GSSS Galma Distt. Mandi to GMS Challing u/c GSSS Tingret Distt. Lahaul & Spiti has filed CWP No. 699/2021 titled as Dimple Kumari, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 08.02.2021 when after hearing the matter the Hon'ble High Court has directed as under:-

"Therefore, in the instant case also, it is open for the petitioner to submit a representation to respondent No.2 highlighting her medical condition within a period of one week from today. In case the petitioner files a representation within this period, then the same shall be decided by the respondent, on its own merit and without disturbing the impugned transfer order insofar as respondent No.3 is concerned (which is the result of implementation of judgment in CWP No.4507 of 2020), within a period of two weeks thereafter. It will be open for the petitioner to avail leave of the kind due during the aforesaid period. With these observations, the writ petition stands disposed of, so also the pending miscellaneous application(s), if any."

The department has received representation of Smt. Dimple Kumari TGT (NM) u/t from GSSS Galma Distt. Mandi to GMS Challing u/c GSSS Tingret Distt. Lahaul & Spiti wherein the concerned teacher has requested that she may kindly be adjusted in GHS, Narwandhi u/c GSSS Sianj (Mnd.) or GSSS Mandap Distt. Mandi on medical grounds. At present the post of TGT(NM) is lying vacant in GHS, Narwandhi u/c GSSS Sianj (Mnd.)

Therefore, keeping in view the position stated above, request made by Smt. Dimple Kumari TGT (NM) is considered sympathetically and she is hereby adjusted at GHS, Narwandhi u/c GSSS Sianj (Mnd.) against vacancy without TTA/JT. The representation of the petitioner is disposed of accordingly.

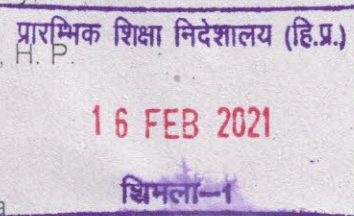
