Whereas, Sh. Anil Kumar Rana, TGT (NM) who is u/t from GSSS Jambal Distt. Kangra to GSSS Ail Distt. Chamba has filed CWP No. 5796/2020 titled as Anil Kumar, TGT (NM) Vs. State of H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 08.01.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

*"Consequently, the writ petition is allowed, and, the impugned transfer order is cancelled, in so far, it relates to the writ petitioner. However, the transfer of co-respondent No.4 be sympathetically considered, and, his transfer be made to a soft station, within, the State of Himachal Pradesh, especially, for, his ensuring qua his afore ailments becoming hence mitigated. Pending applications stand disposed of accordingly."*

In compliance to the directions of the Hon'ble High Court respondent No.4 i.e Sh. Sanjeev Kumar has attended personal hearing on 19.02.2021 and requested that he may kindly be adjusted in GSSS Balera (CBA) or GMS Baduhi Khas u/c GSSS Baduhi (KGR) or GMS Kuffer Dhar u/c GSSS Rajgarh Distt Sirmour on medical grounds. At present the post of TGT(NM) is lying vacant in GMS Kuffer Dhar u/c GSSS Rajgarh Distt Sirmour.

Therefore, keeping in view the position stated above, request made by Sh. Sanjeev Kumar, TGT(NM) is considered sympathetically and he is hereby adjusted in GMS Kuffer Dhar u/c GSSS Rajgarh Distt Sirmour against vacancy, without TTA/JT, on his own request. Representation of the applicant is disposed of accordingly.

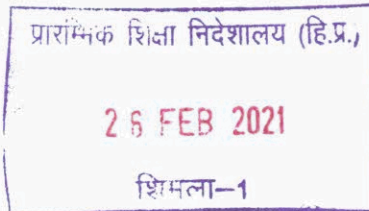
