In the matter of: CWP. No. 970/2021-titled as Baldev Singh, TGT (NM) Vs. State of H.P. & Others.

Whereas, Sh. Baldev Singh, TGT (NM) u/t from GSSS Saleti to GMS Serkao u/c GSSS Chobia Distt Chamba has filed CWP No. 970/2021-titled as Baldev Singh, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer/adjustment. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 22.02.2021 when after hearing the matter the Hon'ble High Court has directed as under:-

"In the meantime, respondents concerned, are directed not, to, relieve the writ petitioner from the station concerned, and, if the order of transfer has been enforced, thereupon, respondents are directed, to, permit the writ petitioner to avail, the, leave of kind due, and, the salary of the writ petitioner, shall be disbursed from the station concerned. All pending application(s) stands disposed of."

As per approval conveyed by the competent authority, the petitioner viz: Sh. Baldev Singh TGT (NM) was transferred from GSSS Saleti (Kgr) to GMS Serko u/c GSSS Chobia (Cba) vice Sh. Vikram Singh TGT (NM) being longer stayee on 17.2.2021 and he was relieved from GSSS Saleti to GMS Serko u/c GSSS Chobia (Cba) by the Principal GSSS Saleti (Kgr) vide relieving order No:EDN-Saleti(B-3)/829(IV) dated 22.2.2021. However, above transfer orders were cancelled again with the prior approval of the competent authority on dated 22.02.2021 and the petitioner was readjusted in GSSS Galani (SML) (which is soft station) vice Sh. Rajneesh Kumar TGT (NM) on 22.02.2021. Since, the petitioner has already been adjusted in GSSS Galani (SML) which is a soft station hence, his request for further adjustment in GHS Punani u/c GSSS Pirsaluhi (Kgr) or GMS Tikkar u/c GSSS Pirsaluhi (Kgr) or GMS Bhindla u/c GSSS Takoli Distt Una against longer stayee cannot be considered at this stage. TGT being a state cadre can be transferred to any where in the State as per transfer policy. Moreover, the petitioner has not served hard/tribal area till-todate.

Since, the petitioner has already been relieved by the Principal concerned, he is hereby allowed to avail leave of kind due and the salary of the petitioner shall be disbursed from the station concerned. The petitioner is hereby directed to join in GSSS Galani (SML) immediately.

Representation of the petitioner is disposed of accordingly.

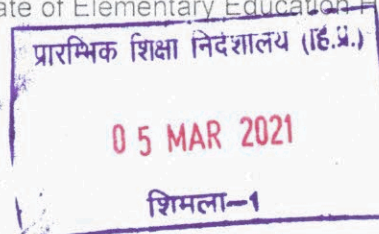
