Whereas, Sh. Sunil Kumar, TGT(NM) who is presently working in GSSS, Goonsari Distt. Shimla has filed CWP No. 4679/2020 titled as Sunil Kumar Vs. State of H.P. before the Hon'ble High Court of H P regarding his transfer from GSSS, Goonsari Distt. Shimla to a soft area after completion of normal tenure. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 28.10.2020, when after hearing the matter the Hon'ble High Court has directed as under:-

The petitioner is working in the sub-cadre/ difficult area since 2014 and has completed six years of service there. He is, thus, entitled to be transferred and posted in soft area in terms of the transfer policy.

"Accordingly, the present petition is disposed of by permitting the petitioner to file a representation clearly specifying therein five stations of his choice, out of which, one should essentially be outside his home district and in case such representation is made within a week from today, then the respondents shall consider and decide the same in accordance with the transfer policy and also instructions issued from time to time and pass necessary consequential orders of posting the petitioner in any one of the five stations opted by him within a further period of three weeks. Pending application(s), if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court representation of the petitioner was submitted by the Advocate of the petitioner on 29.1.2021 wherein it has been requested that the concerned teacher may be transferred from GSSS Goonsari Distt. Shimla to GMS Hanoh u/c GSSS Bhareri (Hmr.) (due to retirement of present incumbent on 31.01.2021) or GMS Khirki u/c GSSS Karot (Hmr.) on promotion or GSSS Ghagas (Blp.) on promotion or GHS Jhatwar (Hmr.) on Promotion .As per directions issued by the Hon'ble High Court the petitioner was required to specify five stations of his choice out of which , one should essentially be outside his home district . But the petitioner has specified only four stations.

I have perused the record carefully and it appears that there is no school with the name of GMS Hanoh u/c GSSS Bhareri in Distt Hamirpur. In GMS Khirki u/c GSSS Karot (Hmr.) there is no longer stayee. The present incumbent i.e Smt. Ranjna is working w.e.f. 7.10.19 and is having short stay. In GSSS Ghagas (Blp.) there are two TGTs (NM) i.e. Smt. Rekha Kumari working since 21.12.20 and the other TGT (NM) i.e. Sh. Ramesh Sharma TGT (NM) working since 3.7.20 and both are having short stay. In GHS Jhatwar (Hmr.) Sh. Parveen TGT (NM) is working since 17.12.20 and he too has not completed normal tenure.

Presently there is no longer stayee in the aforesaid three schools mentioned by the petitioner in his representation , hence his request cannot be considered at this stage
