Himachal Pradesh (Regarding Transfer)  
ORDER

Sh.Gurdass Ram TGT (Arts) presently working at GMS Banibasa u/c GSSS  
Khummi Distt. Shimla has filed CWP No:723/2021- before the Hon'ble High Court regarding  
transfer from GMS Bani Bassa u/c GSSS Khummi (SML) to Distt. Mandi. The case was listed  
on 11.02.2021, when the same has been disposed of with the following directions:-

*After arguing for a consideration period, learned counsel for the  
petitioner seeks permission to withdraw this petition with liberty to pursue his representation  
dated 5.1.21(Annexure P-3) pending with respondent No.2. The prayer being innocuous is  
allowed. Accordingly, the present petition is dismissed as withdrawn with leave and liberty for.  
Pending miscellaneous application(s) if any shall also stand disposed of.*

In-compliance to the order passed by the Hon'ble High Court the  
petitioner was called for personal hearing on 9.3.2021 which was duly attended by him. As per  
order of the Hon'ble High Court . I have perused annexure P-3 carefully wherein the petitioner  
has requested that he may be adjusted in Distt. Mandi as he is a chronic patient of Atopic  
Dermatitis and allergic bronchitis since long. To establish this claim he has attached medical  
prescription of BBMB Hospital Sundernagar H.P, issued by Sr. Medical Officer BBMB Slapper  
Sundernagar H.P. on 2.1.2021. For the sake of convenience advice of Sr. Medical Officer is  
reproduced below:-

*" the incumbent viz :Sh. Gurdass Ram is serving in GMS Banibassa (SML)  
which is at a very high altitude. The climate is not suitable for his health and it is advised that he  
may serve at lower altitude to avoid environment allergic problem and where good medical  
facilities in emergency situation is available."*

Keeping-in-view the health conditions of the petitioner, his request is  
considered sympathetically and he is hereby adjusted in GSSS Toukhala Distt. Mandi against  
vacancy.

Accordingly representation stands decided.
