Whereas, Jyoti Prakash Suman, TGT (NM) GHS Kathachi Distt. Mandi has filed CWP No. 780/2021-titled as Jyoti Prakash Suman, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GHS Kathachi Distt. Mandi (soft area) after completion of normal tenure to in Distt. Bilaspur / Mandi. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 16.02.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

" In view of above, respondents are directed to decide the representation of petitioner by passing a speaking and reasoned order on or before 16th March, 2021. Needless to say that order shall be passed after giving the personal hearing to petitioner, if desired so. Petition stands disposed of accordingly including any application(s)"

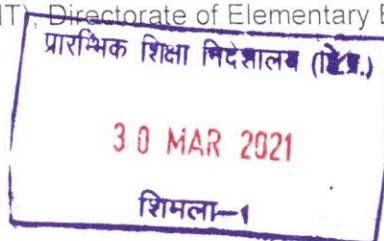

Whereas, Sh.Lal Man, TGT (NM) contract GHS Thangi Distt. Kinnaur has filed CWP No. 846/2021-titled as Lal Man, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GHS Thangi Distt. Kinnaur Tribal Area after completion of normal tenure to soft area in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 18.02.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

" In view of above, present petition is disposed of with a direction to respondent No. 2/competent authority to consider the representations (Annexure P-1 & P-3) which are pending consideration since January, 2021, on or before 31st March, 2021, by giving opportunity of hearing to the petitioner, if desired so, by passing a speaking and reasoned order, in accordance with the transfer policy. As the stations of choice mentioned in the petition and in the representations (Annexure P-1 & P-3) are different and, as a matter of fact, no station of choice has been mentioned in the representations, therefore, the petitioner is granted liberty to file a fresh detailed representation, mentioning the stations of his choice, if so desired, on or before 25th February, 2021, before respondent No. 2 and in case no such fresh representation is made, the case of the petitioner shall be considered by respondent No. 2 on the basis of the representations (Annexure P-1 & P-3) already made."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 18.03.2021 and submitted his representation wherein he requested that he may kindly be adjusted in GSSS Galma or GMS Kandhi u/c GSSS Galma or GSSS Jahal Distt. Mandi, against vacancy or longer stayee, or being caused due to promotion of TGTs.

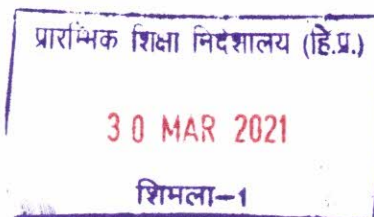

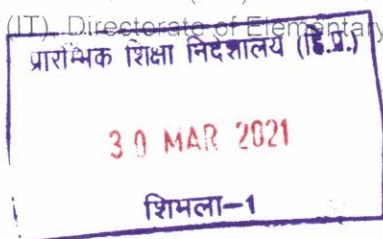
