Whereas, Smt. Uma Dhiman, TGT (NM) who is u/t from GHS Gujrodhar u/c GSSS Jassal Distt. Mandi to GMS Jangal u/c GSSS Alampur Distt. Kangra has filed CWP No. 729/2021 titled as Uma Dhiman, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 24.03.2021 when after hearing the matter the Hon'ble High Court has directed as under:-

"Consequently, the instant petition is disposed of with a direction to the petitioner as also respondent No. 5 to appear before the 2nd respondent on 27th March, 2021, who, after hearing their individual grievances shall issue necessary and consequential orders of transfer/posting. Till then interim order shall remain continue. Pending application(s), if any, stand(s) disposed of."

In compliance to the directions of the Hon'ble High Court Himachal Pradesh, the petitioner and respondent No.5 submitted representation on 27.3.2021. During hearing Smt. Uma Dhiman, TGT (NM) has requested that she may kindly be allowed to continue at GMS, Jangal u/c GSSS, Alampur Distt. Kangra. Respondent No.5 i.e Smt. Babita Kumari, TGT (NM) has also requested that she may kindly be adjusted in GHS Barram Distt kangra.

On the perusal of relevant records, it reveals that Smt. Uma Dhiman, TGT (NM) was transferred from GHS Gujrodhar u/c GSSS Jassal Distt. Mandi to GMS Jangal u/c GSSS Alampur Distt. Kangra vice Smt. Babita Kumari, TGT (NM) vide this Directorate order dated, 06.02.2021 with the prior approval of competent authority after completion of her normal tenure at her present place of posting. Smt. Uma Dhiman, TGT (NM) has joined at GMS Jangal u/c GSSS Alampur Distt. Kangra on dated, 15.02.2021. and thus she has extremely short stay at the aforesaid school.

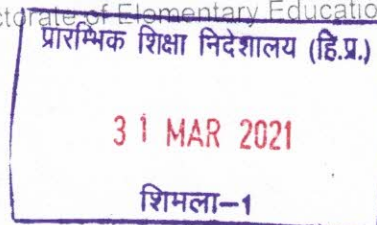
