Whereas, Sh. Baldev Singh, TGT (NM) u/t from GSSS Saleti to GSSS Galani Distt Shimla has filed CWP No. 1385/2021-titled as Baldev Singh, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer/adjustment. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 19.03.2021 when after hearing the matter the Hon'ble High Court has directed as under:-

"Consequently, the instant petition is disposed of with the direction to the petitioner to file a representation before the respondent concerned, within a period of 10 days from today, which shall be considered by the respondent concerned, sympathetically. Needless to say, while considering the afore representation, the petitioner shall be afforded an opportunity of personal hearing, and his representation shall be decided by the authority concerned, by passing a speaking order. It is made clear that till the representation is not decided, the petitioner would be allowed to avail the leave of kind due, in terms of order dated 22.2.2021, passed by this Court in CWP No. 970 of 2021. Since in the aforesaid order, the respondents have been already directed to disburse the salary of the petitioner from the station concerned, this Court hopes and trusts that respondents would not make any delay, as far as the disbursement of the salary of the petitioner is concerned. In view of above, the present petition is disposed of. The pending application(s), if any, are also disposed of.

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 01.04.2021 and submitted his representation wherein he has requested that he may kindly be adjusted in GMS Punani u/c GSSS Pirsaluhi or GMS Tikkar u/c GSSS Pirsaluhi or GSSS Pirsaluhi or GMS Magro u/c GSSS Aloh or GMS Kukahar u/c GHS Sard Dogri or GSSS Kaloha or GSSS Kuhna Distt. Kangra, against vacancy or longer stayee.

The petitioner has requested for adjustment in GMS Tikkar u/c GSSS Pirsaluhi Distt. Kangra against longer stayee. After verifying the facts it has been noticed that Sh. Anil Kumar TGT (NM) is working in GMS Tikkar u/c GSSS Pirsaluhi Distt. Kangra since 25.02.2006.

Hence, petitioner is hereby adjusted in GMS Tikkar u/c GSSS Pirsaluhi Distt. Kangra vice longer stayee i.e. Sh. Anil Kumar TGT (NM) on vice-versa basis with TTA/JT. The representation of the petitioner is disposed of accordingly.

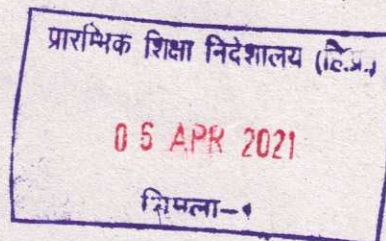
