Whereas, Sh. Bikram Singh, TGT (NM) GHS Graman u/c GSSS Thaltukhod Distt. Mandi has filed CWP No. 1494/2021-titled as Bikram Singh, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GHS Graman u/c GSSS Thaltukhod Distt. Mandi to soft area in Distt. Mandi or Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 10.03.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"After arguing the matter for some time, the learned counsel for the petitioner seeks leave to make a representation to the respondents to consider the case of the petitioner for his transfer. His submission is placed on record.

3. In view of the submission made, the petitioner is permitted to make a representation to the respondents. As and when the representation is made, the same shall be considered in the manner known to law, as expeditiously as possible.

4. The writ petition is disposed off accordingly. Pending miscellaneous applications are also disposed off."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 01.04.2021 and submitted his representation wherein he has requested that he may kindly be adjusted in GMS Hardbehra u/c GSSS Chauntra Distt. Mandi, GHS Sarsawa or GSSS Rakkar Distt. Kangra against vacancy or longer stayee, or being caused due to promotion of TGTs.

On the perusal of the record, it reveals that Sh. Bikram Singh, TGT (NM) is working in GHS Graman Distt. Mandi since 20.07.2018 and having short stay at his present place of posting as he has not completed three years of stay as per policy framed by the Government.

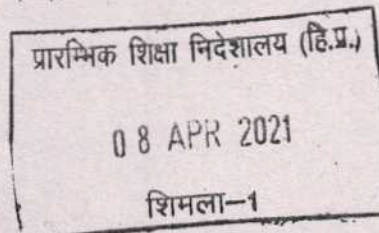
Therefore, keeping in view the position stated above, request made by Sh. Bikram Singh, TGT (NM) on 01.04.2021 cannot be considered at this stage and the same is hereby rejected. The representation of the petitioner is disposed of accordingly.

In the matter of: CWP. No. 1018/2021-titled as Kusum Lata, TGT (NM) Vs. State of H.P. & Others.

Whereas, Smt. Kusum Lata, TGT (NM) who is u/t from GHS Chhaterpipli Distt. Mandi to GHS Lambsafar Distt. Mandi has filed CWP No. 1018/2021 titled as Kusum Lata, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer/adjustment in Distt.Mandi. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 23.02.21, when after hearing the matter the Hon'ble High Court has directed as under:-

" This petition is disposed of by permitting the petitioner to file a representation by giving reasons and grounds for recalling the transfer order before the respondents State/competent authority within one week from today and the respondents-State/competent Authority are directed to examine the same and pass appropriate orders within a week, thereafter. Till then, the petitioner is at liberty to avail leave of the kind due. Pending application(s), if any, stands disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner attended personal hearing on 01.04.2021. The petitioner requested that she may kindly be adjusted in GHS Reur or GHS Bhadiar or Kolni Dhalwan or GSSS Tikkari or GHS Pipli Hawani Distt. Mandi against vacancy which will accrue due to promotion of TGTs to the cadre of PGTs.

On the perusal of relevant records, it reveals that Smt. Kusum Lata, TGT (NM) was transferred from GHS Chhaterpipli Distt. Mandi to GHS Lambsafar Distt. Mandi vice Vishwajeet TGT (NM) vide this Directorate order dated, 20.02.2021 with the prior approval of competent authority after completion of her normal tenure at present place of posting. Petitioner i.e Smt. Kusum Lata, TGT (NM) has joined at GHS Lambsafar Distt. Mandi on dated, 03.03.2021.

The petitioner has submitted in her representation that she may be adjusted GHS Reur or GHS Bhadiar or Kolni Dhalwan or GSSS Tikkari or GHS Pipli Hawani Distt. Mandi against vacancy. However, transfer and posting at a specific place can not be claimed as a matter of right. So far as the personal issues raised by the petitioner in her representation are concerned, every employee has to manage his her personal matters at his/her own level by making suitable arrangement and is required to perform duty as per requirement of service. Moreover the petitioner has already joined at GHS Lambsafar Distt Mandi on 03.03.2021.

Therefore, keeping in view the position stated above, representation made by Smt. Kusum Lata, TGT (NM) is not tenable and the same is hereby rejected. Representation of the petitioner is disposed of accordingly.

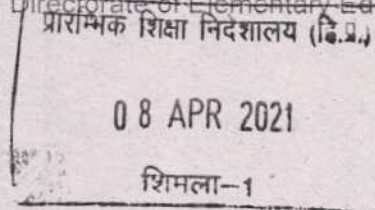

Whereas, Sh. Sanjay Kumar, TGT (NM) GMS Ghulei u/c GSSS Bairagarh Distt. Chamba has filed CWP No. 904/2021-titled as Sanjay Kumar TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GMS Ghulei u/c GSSS Bairagarh Distt. Chamba to soft area Distt Chamba-or Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 19.02.2021, when after hearing the matter the Hon'ble High Court has directed as under:-


"In addition, petitioner is also at liberty to file a fresh detailed representation, if advised so, before the Director Elementary Education, Himachal Pradesh directly on or before 27th February, 2021. In case no fresh representation is filed, respondent No.2 shall take a final decision as directed hereinabove on the basis of representation dated 8.9.2020, Annexure P-2, in accordance with law and policy invoked within the prescribed period. Petition stands disposed of accordingly including any pending application(s)."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 01.04.2021 and submitted his representation he has requested that he may kindly be adjusted in GMS Chakra u/c GSSS Sherpur (Cba) or GSSS Nagali (Cba) or GHS Bailly (Cba) or GMS Kandreti u/c GSSS Masroor Distt. Kangra, against vacancy or longer stayee.



Whereas, Sh. Narinder Singh, TGT (NM) who is u/t from GHS Dehrian Distt. Kangra to GSSS Tissa Distt. Chamba has filed CWP No. 1089/2021 titled as Narinder Singh, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in Distt.Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 25.02.21, when after hearing the matter the Hon'ble High Court has directed as under:-

"In view of the above, the writ petition is disposed of by permitting the petitioner to make a representation within a period of one week from today. On receipt of such representation, the respondents are directed to consider the case of the petitioner and pass appropriate orders within a period of one week thereafter. Till then, the petitioner may not be compelled to join the transferred station and he is at liberty to avail the leave of kind due. Pending application(s), if any, stand(s) disposed of."

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 01.04.2021 The petitioner did not attend the personal hearing on this day. However the petitioner filed representation on dated, 05.04.2021.
