In the matter of: CWP. No. 901/2021-titled as Raman Singh, TGT (NM) Vs. State of H.P. & Others.

Whereas, Sh. Raman Singh, TGT (NM) GMS Satyas u/c GSSS Bairagarh Distt. Chamba has filed CWP No. 901/2021-titled as Raman Singh TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GMS Satyas u/c GSSS Bairagarh Distt. Chamba to soft area of Distt Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 19.02.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"In view of above, respondent No.2 is directed to decide the representation of petitioner by passing a speaking and reasoned order on or before 1st April, 2021. Needless to say that order shall be passed after giving the personal hearing to petitioner, if desired so. 6.Petition stands disposed of accordingly including any pending application(s)."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 01.04.2021 and submitted his representation wherein he has requested that he may kindly be adjusted in GMS Harijan u/c GHS Tahlian or GHS Tahlian or GSSS Baranda or GSSS Sidhpur Ghar or GHS Ludhian Distt. Kangra, against vacancy or longer stayee.

On the perusal of the record, it is found that the petitioner is working in GMS Satyas u/c GSSS Bairagarh Distt. Chamba since 10.08.2017 and he has completed his normal tenure at his present place of posting. GMS Satyas u/c GSSS Bairagarh Distt. Chamba falls in Hard Area.

*As per provisions contained in Comprehensive Guiding Principles -2013 for regulating the transfer of State Government employees" para 16.1 on completion of normal tenure in difficult/tribal/hard/remote area the concerned officers/officials will have an option of five stations of choice which will be for more than one distt. and as far as possible, efforts will be made to post them in any of one station of their choice of that category of stations in which he/she has not served earlier."*


The petitioner has requested for adjustment in GMS Harijan u/c GHS Tahlian or GHS Tahlian or GSSS Baranda or GSSS Sidhpur Ghar or GHS Ludhian Distt. Kangra, against vacancy or longer stayee. After verification of record it has been noticed that there is no longer stayee in GMS Harijan u/c GHS Tahlian (KGR) in GHS Tahlian or GSSS Baranda or GHS Ludhian Distt. Kangra moreover, the incumbents serving in these institutions have already served hard area and can not be transferred again to hard area vice petitioner.

In GSSS Sidhpur Ghar Distt. Kangra one Sh. Sushil Kumar TGT (NM) is working since 13.08.2015 and has completed normal tenure as per transfer policy.

The petitioner has requested for adjustment in GSSS Sidhpur Ghar Distt. Kangra against longer stayee. After verifying the facts it has been noticed that Sh. Sushil Kumar TGT (NM) is working in GSSS Sidhpur Ghar Distt. Kangra since 13.08.2015.



Hence, petitioner is hereby adjusted in GSSS Sidhpur Ghar Distt. Kangra vice longer stayee i.e. Sh. Sushil Kumar TGT (NM) on vice-versa basis with TTA/JT. The representation of the petitioner is disposed of accordingly.


