Vs. State of H.P. & Others.

Whereas, Sh. Sudhir Awasthi TGT (NM) GSSS Jhajakothi Distt. Chamba has filed CWP No. 1081/2021-titled as Sudhir Awasthi TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GSSS Jhajakothi Distt. Chamba to Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 25.02.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"The plea of the petitioner is to issue a directions to the respondents to transfer him from the present place of posting to anywhere in Tehsil Baijnath, District Kangra, H.P. 2. Under these circumstances, we deem it just and necessary to direct the respondents to consider the representation of the petitioner (Annexure P-3), in accordance with the transfer policy and pass appropriate orders thereon, within a period of two weeks from the date of receipt of copy of this order. The writ petition is disposed off accordingly, so also the pending miscellaneous application(s) if any."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 01.04.2021 and submitted his representation wherein he has requested that he may kindly be adjusted in GHS Jandpur or GSSS Deol or GHS Gadiara or GMS Rajot u/c GSSS Rakkar or GHS Tikkari Distt. Kangra, against vacancy or longer stayee.


On the perusal of the record, it is found that the petitioner is working in GSSS Jhajakothi Distt. Chamba since 07.11.2016 and he has completed his normal tenure at his present place of posting. GSSS Jhajakothi Distt. Chamba fall in Hard Area.

"As per provisions contained in Comprehensive Guiding Principles -2013 for regulating the transfer of State Government employees" para 16.1 on completion of normal tenure in difficult/tribal/hard/remote area the concerned officers/officials will have an option of five stations of choice which will be for more than one distt. and as far as possible, efforts will be made to post them in any of one station of their choice of that category of stations in which he/she has not served earlier."

The petitioner has requested for adjustment in in GHS Jandpur or GSSS Deol or GHS Gadiara or GMS Rajot u/c GSSS Rakkar or GHS Tikkari Distt. Kangra, against vacancy or longer stayee. After verification of record it has been noticed that there is no longer stayee in GHS Jandpur (KGR) or in GHS Tikkri. In GSSS Deol the incumbent has already served hard area and can not be transferred again to hard area vice petitioner. Moreover, there is no school in the name of GMS Rajot u/c GSS Rakkar (Baijnath) KGR.

In GHS Gadiara Distt. Kangra one Smt. Neelima Kumari TGT (Med) is working since 10.9.2008 and has completed normal tenure as per transfer policy.

Hence, petitioner is hereby adjusted in GHS Gadiara Distt. Kangra vice longer stayee i.e. Smt. Neelima Kumari TGT (NM) on vice-versa basis with TTA/JT. The representation of the petitioner is disposed of accordingly.




