In the matter of: CWP No: 2229/2021-titled as Promila Devi,TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer)

ORDER

Sh. Promila Devi,TGT (Arts) presently working at GSSS Thachi Distt. Mandi has filed CWP No. 2229/2021- before the Hon'ble High Court regarding transfer from her present place of posting which is in hard area to soft area of Distt. Mandi. The case was listed on 6.04.2021. when the same has been disposed of with the following directions:-

*"Consequently, this petition is disposed of with liberty to petitioner to make fresh representation to the respondent/authorities concerned giving five stations of her choice, which must be spread in more than one district, within one week from today, in the light of Clause 16.1 read with clause 16.5 of the transfer policy. On receipt of such representation, the respondent/authorities shall decide the presentation of the petitioner, in the light of the transfer policy occupying the field, within two weeks. It is clarified that while deciding the presentation of the petitioner the respondents shall consider the stations of choice of the petitioner as mentioned in her representation, subject to the condition that the incumbents posted there have completed their normal tenure of posting, in accordance with the transfer policy. In case none of them have completed the normal tenure then the office of the respondent/authorities shall get in touch with the petitioner apprising her of vacant stations where the incumbents have completed their normal tenure and the possible places where the petitioner can be posted. Pending miscellaneous application(s) if any also stand disposed of".*

In compliance to the order passed by the Hon'ble High Court the petitioner has submitted her representation to the this Office on 22.4.2021. As per order of the Hon'ble High Court, I have perused representation dated 28.12.2020 carefully wherein the petitioner has requested that she may be adjusted in the stations of her choice in soft area as her husband is physically handicapped. She has submitted the medical certificate of her husband in this regard.

Keeping in view the health conditions of the husband of the petitioner, her request is considered sympathetically and she is hereby adjusted in GSSS Paplog Distt. Mandi against vacancy.

Accordingly representation stands decided.
