ORDER

Sh. Babli Devi,TGT (Arts) presently working at GSSS Purthi (Pangi) Distt. Chamba has filed CWP No. 1381/2021- before the Hon'ble High Court regarding transfer from her present place of posting which is in hard area to soft area of Distt. Chamba. The case was listed on 6.3.2021. when the same has been disposed of with the following directions:-

"Notice. Mr. R.S. Dogra, learned Senior Additional Advocate General, m takes notice on behalf of the respondents.

2. The plea of the petitioner is that not withstanding the representation made by her in terms of Annexure P-1, the respondents are not responding to the same.

3. The learned Senior Additional Advocate General appearing for the respondents submits that the representation shall be considered and disposed off in accordance with law, within a period of four weeks from today. His submissions is placed on record.

4. The writ petition is disposed off accordingly, so also the pending miscellaneous application(s), if any."

In compliance to the order passed by the Hon'ble High Court the petitioner has requested in her representation in Annexure P-1 that she may be adjusted in the stations given of her choice in the said representation. As per order of the Hon'ble High Court, I have perused representation petitioner carefully wherein the petitioner has requested that she may be adjusted in the stations of her choice in soft area of Kullu District as she has completed more than normal tenure in her present place of posting

Keeping in view the above position the request of the petitioner is considered sympathetically and she is hereby transferred from GSSS Purthi Distt. Chamba to GSSS (Girls) Sultanpur, Distt.Kullu, against vacancy being caused due to promotion of present incumbent.

Accordingly representation stands decided.
