Whereas, Kuldeep Kumar, TGT(NM) who is presently working in GSSS B.C. Thach Distt. Mandi has filed CWP. No. 1830/2021 tiled as Sh. Kuldeep Kumar Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS B.C. Thach Distt.Mandi to District Mandi. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 22.3.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"In such circumstances, we dispose of the instant writ petition by directing the respondents to consider and decide the representation(s) made by the petitioner within a period of 15 days from today by passing a speaking order. Pending application(s), if any, also stands disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 21.06.2021 and requested that he may kindly be transferred from Govt. Sr. Sec. School B.C. Thach Distt. Mandi to GMS Shaleter u/c GSSS Kotli (Mandi)/GHS Bhaganv u/c GSSS Kotli (Mandi)/ GHS Khalanu (Mandi).

On the perusal of the record, it is found that the petitioner is working in GSSS B.C. Thach Distt. Mandi since 13.8.2018 which is a hard area and he has not completed his normal tenure at his present place of posting. Moreover, at present the post of TGT(NM) is not lying vacant in any institutions mentioned by the petitioner.

Therefore, keeping in view the position stated above, request made by Sh. Kuldeep Kumar, TGT (NM) cannot be considered at this stage and the same is hereby rejected. The representation of the petitioner is disposed of accordingly.

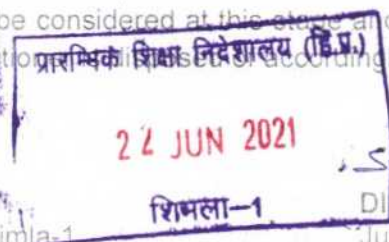
Whereas, Rajesh Kumar, TGT(NM) who is presently working in GSSS Deot Distt. Shimla has filed CWP No. 2782/2021 tiled as Rajesh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer from GSSS Deot Distt. Shimla to District Una after completion of normal tenure. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 5.5.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"Accordingly, we deem it proper to dispose of the instant petition by permitting the petitioner to make representation within a period of one week from today. In the event of the petitioner making a representation within the stipulated time, the respondents shall consider and decide the same by passing consequential order of his transfer within a period of two weeks on receipt of the representation. The petition is disposed of in the aforesaid terms, so also the pending miscellaneous application(s), if any.

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 21.06.2021 and requested that he may kindly be transferred from Govt. Sr. Sec. School Deot Distt. Shimla to GSSS Chaksrai/Repoh Misra/ Behar Jaswan/GMS Amb u/c GSSS Amb & GMS Thara u/c GSSS Nehri District Una against vacancy.

On the perusal of the record, it is found that the petitioner is working in GSSS Deot Distt. Shimla since 29.11.2016 which is a soft area and he has completed his normal tenure at his present place of posting. At present the post of TGT(NM) is not lying vacant in any institutions mentioned by the petitioner.

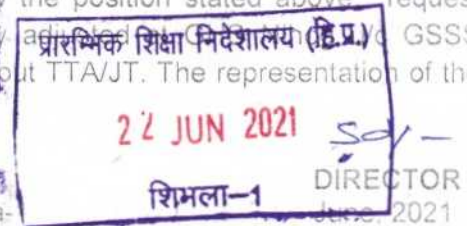
Whereas, Smt. Aditi Panwar, TGT(NM) has filed CWP No. 6025/2021 titled as Smt. Aditi Panwar Vs. State of H.P. before the Hon'ble High Court of H.P. against her transfer from GSSS Sainwala Distt. Sirmour to Timbi District Sirmour vice Smt. Nirmala Chauhan, TGT(NM) & vice-versa. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 26.3.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"It is made clear that in case the writ petitioner, is, faced with certain hardships, and, intends to seek her posting and the posting of her husband, at the station concerned, it is open to them to make a representation, to the respondent authority, within a week, whereupon, the competent authority, after affording an opportunity, of personal hearing to the writ petitioner, and to her husband, shall make a speaking decision thereon, within one week, thereafter. It is also clarified that within period of two weeks, the parties shall maintain status quo. In view of this, the instant writ petition is disposed of. Also, the pending application(s), if any, are disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 28.04.2021 and requested that she may kindly be adjusted in Govt. Sr. Sec. School Moginand/GHS Nihog u/c GSSS Banethi/GMS Jodhon u/c GSSS Trilokpur Distt. Sirmour against vacancy.

On the perusal of the record, it is found that the petitioner has been transferred from GSSS Sainwala Distt. Sirmour to GSSS Timbi District Sirmour vice Smt. Nirmala Chauhan, TGT(NM) on the completion of normal tenure with the prior approval of competent authority. At present the post of TGT(NM) is lying vacant in GHS Nihog u/c GSSS Banethi District Sirmour.

Whereas, Smt. Asha Devi, TGT(NM) who is presently working in GSSS Pressi Distt. Mandi has filed CWP No. 2593/2021 tiled as Asha Devi Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer from GSSS Pressi Distt. Mandi to District Hamirpur/Una after completion of normal tenure. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 24.4.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"Since this Court cannot issue mandamus to the respondents to post the petitioner at a particular station, we do not find any merit in the present petition and accordingly, same is dismissed. However, liberty is reserved to the petitioner to, within two weeks from today, file appropriate representation before the appropriate authority, praying therein for her adjustment at the station of her choice, which shall be decided by the Whether reporters of the local papers may be allowed to see the judgment? authority concerned in accordance with law within a period of three weeks thereafter. Needless to say, appropriate authority, while doing the needful, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon. Liberty is also reserved to the petitioner to approach appropriate court of law at appropriate time if she still remains aggrieved. All pending applications also stand disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 21.06.2021 and requested that she may kindly be transferred from Govt. Sr. Sec. School Pressi Distt. Mandi to District Hamirpur(Nadaun/Badsar Block) or Bangana Block District Una against vacancy.

On the perusal of the record, it is found that the petitioner is working in GSSS Pressi Distt. Mandi since 9.10.2017 which is a soft area and she has completed her normal tenure at her present place of posting. At present the post of TGT(NM) is not lying vacant in any institutions located in the aforesaid area mentioned by the petitioner.

Therefore, keeping in view the position stated above, request made by Smt. Asha Devi, TGT (NM) cannot be complied with. The same is hereby rejected. The representation of the petitioner is disposed of accordingly.
