The petitioner Smt. Anita Kaundal,TGT (M) presently working in GSSS, Sehorpian Distt.Kangra has filed CWP No. 2512/2021 titled as Smt. Anita Kaundal . TGT(Med) versus State of H.P. before the Hon'ble High Court H.P. against his transfer from GSSS, Sehorpian(Kangra) to GSSS Seul Distt. Kangra vice Smt. Sheetal Sharma,TGT(Med) The case of the applicant was listed before the Hon'ble High Court on 04-06-2021,when after hearing the matter the Hon'ble High Court disposed of the same with the following direction:-

Consequently, the petition is disposed of by permitting the petitioner to make a representation within one week from today,which shall be considered by the respondents sympathetically and in accordance with law within two weeks from receipt of such representation.The interim order shall continue to operate until final decision on the representation of the petitioner.Pending application(s).if any,stand(s) disposed of.

As per the direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 23-06-2021. The petitioner attended the personnel hearing on schedule date and time .On the during of personal hearing has requested that she may be adjusted in GSSS Tihri(KGR),GSSS Aluha(KGR),GHS Fakloh(KGR),GHS Bhalun(HMR),GSSS Sunhet(KGR),GSSS Langru(KGR) against longer stayee. The petitioner has further stated that he is facing some difficulties at the domestic front, and hence, he may be posted closer to his home.

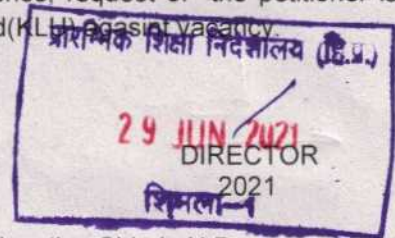
Perusal of record pertaining to the case shows that Smt. Anita Kaundal, TGT(Med) was transferred from GSSS, Sehorpian(Kangra) to GSSS Seul Distt. Kangra vice Smt. Sheetal Sharma,TGT(Med). Smt. Anita Kaundal, TGT(Med) was working in GSSS, Sehorpian(Kangra),since july,2017 and has completed her normal stay as per provision contained in "comperhensive guiding Principles-2013" for regulating the transfer of State Government employees.Transfer and posting to a particular place can not be claimed as a right by the petitioner. However, being a Govt. employee and that too in a State cadre ,request of the petitioner is not tenable.Every employee has to manage his/her personal problems at his/her own level and to ensure performance of duties as per requirement of service. At present the post of TGT(Med) has been filled up at the transfer station of petitioner i.e.GSSS Seul(KGR),due to adjustment of another TGT(Med). Hence, request of the petitioner is not tenable and and she is hereby adjusted at GSSS Bathad(Kullu) against vacancy.
