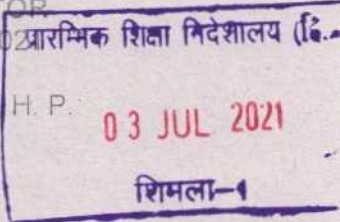

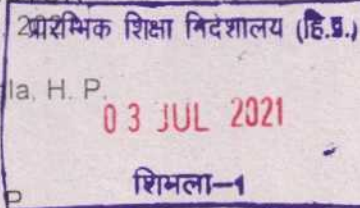

against vacancy.

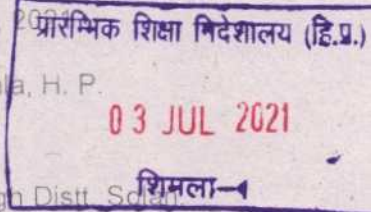
On the perusal of the record, it is found that the petitioner is
