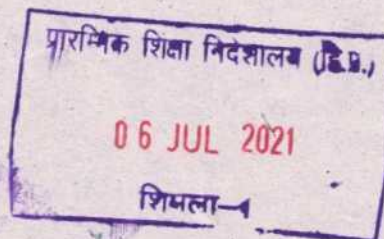
1. The deputation is only for three years, no extension of deputation period will be given in future.

4. The teacher concerned will get the same pay during deputation as he/she was getting in the Education Department.
5. The Pension & Leave contribution shall be regulated as per instructions of the State Govt. from time to time.
6. There should not be departmental enquiry/ vigilance case pending against the teacher.
7. The teacher shall immediate report for further duty, in her parent department, on the expiry of her deputation period failing which she shall be liable for suitable disciplinary and no further service benefits will be extendable to her.
