Whereas, Babu Ram, TGT(NM) who is presently working in GMS Keoli u/c GSSS Thunag Distt. Mandi has filed CWP No. 2842/2021 tiled as Sh. Babu Ram TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Keoli u/c GSSS Thunag Distt. Mandi to District Mandi. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 07.05.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"Consequently, the present writ petition is disposed of with a direction to respondent No.2 to consider the instant case as a representation and decide the same sympathetically within three weeks from today. Pending application(s), if any, also stands disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 06.07.2021 and requested that he may kindly be transferred from GMS Keoli u/c GSSS Thunag Distt. Mandi to GMS Bah u/c GSSS Dhar or GMS Ropi u/c GSSS Padhar Distt. Mandi against vacancy.

On the perusal of the record, it is found that the petitioner is working in GMS Keoli u/c GSSS Thunag Distt. Mandi since 16.03.2018 which is a soft area and he has completed his normal tenure at his present place of posting. The petitioner is a TGT (NM) which comes under state cadre post and can be posted anywhere in the state as per requirement. The petitioner in his representation has specified for his adjustment in GMS Bah u/c GSSS Dhar or GMS Ropi u/c GSSS Padhar Distt. Mandi. However as per transfer policy there is no such provision that allows a government employee serving in soft area to specify stations of his choice for adjustment.

Therefore, keeping in view the position stated above, request made by Sh. Babu Ram, TGT (NM) cannot be considered at this stage and the same is hereby rejected. The representation of the petitioner is disposed of accordingly.
