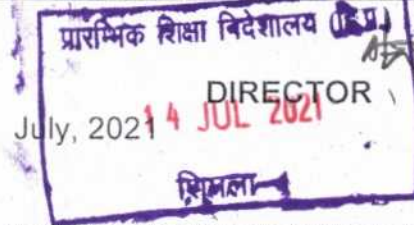

1. The Dy. Director of Elem./ Hr. Education concerned with the directions to intimate the teacher concerned immediately. **(Regd.)**
2. **(Regd.)** All the Heads of Schools concerned. They are directed to take over complete charge from the concerned teachers. The teachers selected for such courses be relieved immediately. The teachers selected for such courses shall have to complete their course within the stipulated period. In case they discontinue /leave the course, the entire expenses, if any, shall be recovered from them and the entire period of the leave will be treated as leave without pay.
3. **(Regd.)** All the teachers concerned with the direction that they may report at H.P.U. Shimla immediately. They have been selected for M.Sc. Course for the Session 2021-23 in H.P. University, Shimla on the following conditions:-
 - (a) That their selection is subject to the approval by the H.P.U. for admission in subject concerned on the basis of B.Sc. degree held by them.
 - (b) The selected candidates will not be allowed increments during the study leave, however, the full benefit of increments will be allowed after the completion of course.
 - (c) That they shall have to execute a bond as required by the University under Rules 53(4)(a)&(b) in favour of H.P. Govt. on Form No. 7 & 8 as appended to CCS Rules 1972 and submit the copy of the same alongwith relieving and joining of the concerned teacher immediately to this Directorate.
 - (d) If any selected candidate does not join the said course, he/she will have to give his/her refusal application (personally) to this Directorate as well as to the Registrar, H.P. University within three days positively.
 - (e) The selected candidates will have to join his/her duties in the previous place of posting /institution from where he/she has been relieved after completing his/her M.Sc. Course.
4. The dealing Assistant dealing with transfer/ appointment seats (E-II Internal).
5. Guard File.

Note:- If the candidates refuse to proceed for the said course, they will be debarred for three years.
