Whereas, Sh. Sushil Kumar, TGT (NM) who is u/t from GSSS Sidhpur Garh Distt. Kangra to GMS Satyas u/c GSSS Bairagarh Distt. Chamba has filed CWP No. 2999/2021 titled as Sushil Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 18.05.21, when after hearing the matter the Hon'ble High Court has directed as under:-

"Consequently, this petition is disposed of with direction to the respondents No.1 and 2/competent authority to decide representation of the petitioner dated 13.04.2021, Annexure P-4, in accordance with law, within three weeks from today. Till decision of the representation, petitioner is permitted to avail the leave of kind due. Pending miscellaneous application(s), if any, also stand disposed of."

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 21.06.2021 / 06.07.2021. The petitioner did not attend the personal hearing on scheduled date and time.

Perusal of relevant records, shows that Sh. Sushil Kumar, TGT (NM) has been adjusted GMS Dhan u/c GSSS Jawali Distt. Kangra vide this Directorate order dated. 01.07.2021 with the prior approval of competent authority. Moreover the petitioner i.e Sh. Sushil Kumar TGT (NM) has already joined at GMS Dhan u/c GSSS Jawali Distt. Kangra.

Therefore, keeping in view the position stated above, representation made by Sh. Sushil Kumar, TGT (NM) is not tenable and the same is hereby rejected. Representation of the petitioner is disposed of accordingly.
