Whereas, Sh. Anil Kumar, TGT (NM) who is u/t from GSSS Majheen Distt. Kangra to GSSS Pattamehlog Distt. Solan has filed CWP No. 2140/2021 titled as Anil Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer/adjustment in Distt.Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 30.03.21, when after hearing the matter the Hon'ble High Court has directed as under:-

"In the facts and circumstances, it will be open for the petitioner to represent to the competent authority within a week from today in respect of deferment of his transfer order till the conclusion of final examination of class +1 of his son. On receipt of such representation within the aforesaid period, the same shall be considered and appropriate order shall be passed by the competent authority within next five days. The petition is disposed off accordingly. Pending miscellaneous applications are also disposed off.

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 28.04.2021 / 06.07.2021. The petitioner did not attend the personal hearing on scheduled date and time.

Perusal of relevant records, shows that Sh. Anil Kumar, TGT (NM) has been adjusted GMS Basin u/c GSSS Lagru Distt. Kangra vide this Directorate order dated, 04.05.2021 with the prior approval of competent authority. Moreover the petitioner i.e Sh. Anil Kumar TGT (NM) has already joined at GMS Basin u/c GSSS Lagru Distt. Kangra.

Therefore, keeping in view the position stated above, representation made by Sh. Anil Kumar, TGT (NM) is not tenable and the same is hereby rejected. Representation of the petitioner is disposed off accordingly.
