In the matter : CWP No.2246/2021 titled as **Rajeev Kumar VS State of H.P. & others(Reg Transfer)**


The Petitioner Sh. Rajeev Kumar,TGT(Med) has filed CWP No. 2246/2021 titled as Sh.Rajeev Kumar ,TGT(M) versus State of H.P. before the Hon'ble High Court of H.P.regrding his transfer from GSSS, Bajotra Distt. Chamba, H.P. to his choice of station after the completion of required tenure as per policy. The case of the applicant was listed before the Hon'ble High Court, Shimla-2 on 07.04.2021, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/order:-

" After arguing for sometime, petitioner's counsel seeks leave to file fresh representation to the concerned respondent regarding his transfer.His request is accepted.He is permitted to make a fresh representation to the concerned respondent pertaining to his transfer and the said respondent thereafter to consider and decide the same,as expeditiously as possible,in accordance with law.Hence,the instant writ petition is disposed off.Pending applications are also disposed off accordingly"

As per the direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 09th July,2021 .The petitioner attended the personal hearing on schedule date and time .During personal hearing he has requested that he may be adjusted in GSSS Samirpur (HMR),GHS Sarad Dogri u/c GSSS Rakkar(KGR),GHS Punani u/c GSSS Peersaluhi Distt Kangra against longer stayee. The petitioner has further stated that he is suffering from disc problem and doctor has advised to avoid long journey in hilly terrain and he may be posted closer to his home.

Perusal of record pertaining to the case shows that Sh. Rajeev Kumar TGT(Med) is working in GSSS Bajotra Distt. Chamba since 23rd Nov,2016 ,has completed his normal tenure at present place of posting. Hence the petitioner is hereby transferred from GSSS Bajotra Distt. Chamba to GSSS Samirpur District Hamirpur vice Sh. Kamaljeet Singh.TGT(Med) against longer stayee.


