Whereas, Virender Kumar, TGT (NM) who is u/t from GHS Dadriana u/c GSSS Bani Distt. Hamirpur to GMSSS Kothkhai Distt. Shimla has filed CWP No. 3767/2021 titled as Virender Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 12.07.2021 when after hearing the matter the Hon'ble High Court has directed as under:-

"In view of the above, the petitioner is permitted to make a representation to the concerned respondent, within three days from today, who shall consider the same and pass appropriate orders, in accordance with law, within a week thereafter, Till then, the petitioner shall not be compelled to join at his place of posting. The writ petition is disposed off accordingly. Pending miscellaneous applications are also disposed off.

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 28.07.2021 and requested that he may kindly be transferred to GHS Pairwin u/c GSSS Maharal (Hmr) or GSSS joure Amb (Hmr) or GSSS Dandro (Hmr) or GHS Bumbloo (Hmr) or GSSS Lathiani (Una) against longer stayee.

On the perusal of relevant records, it is revealed that Sh. Virender Kumar, TGT (NM) is u/t from from GHS Dadriana u/c GSSS Bani Distt. Hamirpur to GMSSS Kothkhai Distt. Shimla has requested for adjustment due to adverse family circumstances in Distt. Hamirpur against longer stayee. After examining the record it has been noticed that one Sh. Pradeep Kataria TGT (NM) is serving in GHS Pairwin u/c GSSS Maharal (Hmr).

Therefore, keeping in view the position stated above, request made by Sh. Virender Kumar, TGT (NM) is hereby acceded to and he is adjusted without TTA/JT on his own request at GHS Pairwin u/c GSSS Maharal (Hmr) vice Sh. Pradeep Kataria TGT (NM) with TTA/JT. The case of the petitioner is disposed of accordingly.
