ORDER

Ms. Sameeksha Gupta TGT (Arts) GSSS Dhangiyara (MND) (SML) has filed CWP No. 2514/2021- before the Hon'ble High Court regarding transfer. The case was listed on 22.4.2021 when the same has been disposed of with the following directions:-

The petitioner who is working as TGT (Arts) as a volunteer teacher at GSSS Bharari (MND) H.P. has come up before this Court seeking transfer from present place of posting on completion of normal tenure of three years . In this regard ,the petitioner has already made a representation dated 3.3.21(Annexure -P4) which is still pending before the concerned authority. Consequently the petition is disposed of directing the first respondent to decide the representation of the petitioner dated 3.3.21(Annexure-P4) strictly in the light of the transfer policy occupying the filed ,with in a period of two weeks .Liberty is reserved to the petitioner to approach this Court again incase if she feels aggrieved and dissatisfied with the out come of the representation

As per order of the Hon'ble High Court we perused Annexure P-4 wherein the petitioner has apprised that she is working in GSSS Dhangiyara (MND) since 10.8.17 and has completed normal tenure. Further it has been stated by the petitioner that due to adverse family circumstances she may be transferred from the present school to either of the following schools:-

a)GSSS Baggi, GSSS Chailchowk, GMS Daan (MND)

Presently there is no vacancy of TGT (Arts) in the above mentioned schools. However, as per her revised representation dated 2.8.21 she is hereby adjusted in GHS Alsoo (MND) against vacancy on her own request without TTA/JT.

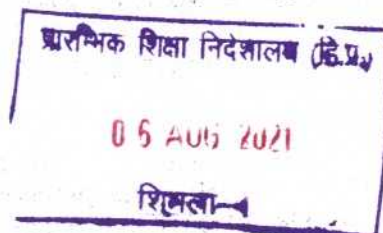
Accordingly representation stands decided.

ORDER

Sh. Dharam Singh TGT (Arts) GSSS Somanachni (MND) (SML) has filed CWP No. 2798/2021- before the Hon'ble High Court regarding transfer. The case was listed on 5.5.2021 when the same has been disposed of with the following directions:-

The petitioner who is working as TGT (Arts) in GSSS Somanachani (MND) has come up before this Court seeking transfer from Hard/difficult area to one of the station of his choice as per clause 16.1 of the Comprehensive Guiding Principles 2013 issued by the State Government which provides the normal tenure of stay of posting in most difficult/difficult/tribal/hard areas shall be two years and three summers. In this regard, the petitioner has already made a representation Annexure P-2 which is still pending before the concerned authority. In view of the nature of the order, we propose to pass no response is required from the respondents. Consequently, this petition is disposed of with a directions to respondents decide the representation of the petitioner, Annexure P-2 in the light of the transfer policy, occupying the field, within two weeks from today Pending application(s) if any are closed.

In pursuance to the order ibid, we perused Annexure P-2 and noticed that the petitioner has requested for adjustment in the following schools:-
1. GSSS Somanachani (MND) (SML) has 177 students (GHS Siun (MND) against longer stay of regular teacher.
2. GHS Gawali (MND) vacant after promotion.
3. GMS Garon u/c GSSS Gumma (Over stay)

Since, post of TGT (Arts) is vacant in GMS Rullang u/c GSSS Barot (MND), hence, the petitioner is hereby transferred from GSSS Somanachani (MND) to GMS Rullang u/c GSSS Barot (MND) on his own request without TTA/JT.
