26.07.2021 subject to adherence of standard SOPs of Education  
Department / GOI.

vacations in schools, Opening of Schools.

Sir/Madam,

In continuation of this Department's letter of even number  
dated: 7<sup>th</sup> June, vide which decision regarding cancellation of 10+2 examination was  
conveyed to the Department of Higher Education and Board of School Education  
Dharamshala, I am directed to invite your attention towards the subject cited above  
and to inform that Government has now taken the following decisions:-

1. The proposal submitted by HP Board of School Education was approved  
with the condition that weightage to marks obtained in Class 10 would be  
reduced by 5 points and that of pre-board results would be increased by 5  
points while calculating the theory marks for each subject. Results of Class  
12<sup>th</sup> would be declared by the 3<sup>rd</sup> week of July, 2021.
2. Vacations will be granted in the summer closing areas as per following  
schedule:-
  - (a) Monsoon break in summer closing areas except Kullu & Lahaul Spiti  
districts: 26.06.2021 to 25.07.2021 (30 days).
  - (b) Monsoon break in Kullu district: 23.07.2021 to 14.08.2021 (23 days)
  - (c) Monsoon break in Lahaul Spiti district: 01.07.2021 to 31.07.2021 (31  
days).




(d) Monsoon break in Winter closing schools: 22.07.2021 to 27.07.2021

3. Online teaching and Har Ghar Pathshala will continue both for winter and summer closing areas students. The summer closing schools will also give projects and assignments to students for vacations which will be evaluated after vacations.
4. Teachers will attend educational institutions w.e.f. 01.07.2021 in Winter closing and Non vacations areas.
5. Health and Education Department will strive to cover maximum number of teaching and non teaching staff of educational institutions for vaccination by the end of June, 2021.
6. Students of Class 12<sup>th</sup>, 10<sup>th</sup>, 8<sup>th</sup> and 5<sup>th</sup> may visit the schools for clarification of doubts, if any, after 07 July, 2021. They will have to seek prior approval from concerned teacher or Principal and shall follow the prescribed SOPs'.


