Whereas, Sh. Om Parkash, TGT (NM) who is presently working in GMS Tranda u/c GSSS Nigulsari Distt. Kinnaur has filed CWP No. 2316/2021-titled as Om Parkash, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GMS Tranda u/c GSSS Nigulsari Distt. Kinnaur Tribal Area after completion of normal tenure to soft area in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 09.04.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"Consequently, without going into the merits of the case, the present petition is disposed of with a direction to the respondents to decide Annexure P-3 within a period of four weeks. Needless to say, opportunity of hearing shall be afforded to the petitioner and a speaking order shall be passed by the respondents. Liberty is reserved to the petitioner to file appropriate proceedings before appropriate Forum, if he still remains aggrieved. Petition stands disposed of in the aforesaid trms alongwith all pending applications.

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 28.07.2021 and requested that he may kindly be transferred from GMS Tranda u/c GSSS Nigulsari Distt. Kinnaur to GSSS Galore (Hmr) or GMS Bela (Hmr) or GSSS Sera (Hmr) or GHS Kohdra (Una) against longer stayee.

On the perusal of the record, it is found that the petitioner is working in GMS Tranda u/c GSSS Nigulsari Distt. Kinnaur since 05.08.2017 which is a Tribal area and he has completed his normal tenure at his present place of posting.

After examining the record it has been noticed that one Sh. Revti Raman TGT (NM) is serving in GHS Kohdra Distt. Una w.e.f. 21.04.2016.

Therefore, keeping in view the position stated above, request made by Sh. Om Parkash, TGT (NM) is hereby acceded to and he is hereby adjusted without TTA/JT on his own request at GHS Kohdra Distt. Una vice Sh. Revti Raman TGT (NM) with TTA/JT. The representation of the petitioner is disposed of accordingly.
