However, this department has already clarified to deposit the RTI fees in specific Head of account for RTI receipts allocated by the Govt i.e. "0070-60-118-01", conveyed vide this department letter No. Per (AR) B(15)-1/2012, dated: 11-09-2019.

Therefore, it is again requested to kindly direct all PIOs and DDOs under your control to adhere the procedures laid in Rule 5 of RTI Rules, 2006 amended time to time and ensure depositing/encashing RTI fees (IPOs/DDs) in specific RTI head of account i.e. "0070-60-118-01" well in time.
