In the matter of: COPC No. 52/2021 in CWP No. 4809/2020 titled as Sarvjit Singh TGT (NM) Vs. State of H.P. & Others.

Whereas, Sh. Sarvjit Singh, TGT (NM) presently working in GMS Dharman u/c GSSS Multhan Distt. Kangra has filed COPC No. 52/2021 in CWP No. 4809/2020 -titled as Sarvjit Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Dharman u/c GSSS Multhan Distt. Kangra to soft area. The above COPC was listed before the Hon'ble High Court Himachal Pradesh on 02.07.2021 when the Hon'ble High Court has directed to the respondent state that the order on the representation be positively passed by the authority concerned on or before 20.7.2021. It is further submitted that the CWP No. 4809/2021 titled as Sarvjit Singh Vs. State of H.P. was listed before the Hon'ble High Court on 30.10.2020 when the following orders have been passed:-

"The writ petition is disposed of with a direction to the respondent concerned to decide the representation(s), of, the petitioner, Annexure P-2 and Annexure-2 and Annexure P-3 in accordance with law, within four weeks and after affording an opportunity of hearing to him. It is made clear that status quo shall be maintained till the representation of the petitioner, is decided by the competent authority, Also, the pending application (s), if any, are also disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 28.04.2021 and he has again called for personal hearing on 27.8.2021 when he attended the same and requested that he may kindly be adjusted in Nagroota Bagwan block against vacancy being caused due to Promotion or GHS Baag Pandol Distt. Mandi, against vacancy, being caused due to retirement of present incumbent on 30.9.2021.

From perusal of record, it has been gathered that the petitioner is working in GMS Dharman u/c GSSS Mutthan Distt. Kangra since 17.11.2017 and has completed more than three years stay. Accordingly, request of the petitioner is considered sympathetically and he is hereby transferred from GMS Dharman u/c GSSS Multhan Distt. Kangra to GHS Baag Pandol Distt. Mandi against vacancy being caused due to retirement of present incumbent on 30.09.2021. The petitioner will join in GHS Baag Pandol Distt. Mandi after the retirement of present incumbent on 30.09.2021. The representation of the petitioner is disposed of accordingly.
