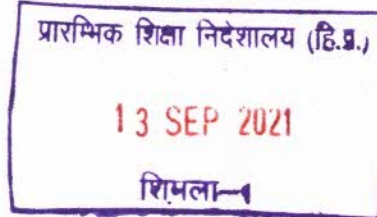
1. These orders be implemented in relaxation of ban on transfers.
