ORDER

Sh. Manglu Ram TGT (Arts) GHS Haraboi Distt Mandi has filed CWP No. 4405//2021- before the Hon'ble High Court . The case was listed on 9.8.2021,when the same has been disposed of with the following directions:-

After arguing the matter for some time,learned counsel for the petitioner submits that he may be granted liberty to file a representation to the respondent no 2 He is permitted to do so, within a period of one week .Respondenn no.2 is directed to consider the same and pass appropriate orders , within a period of one week thereafter.Pending miscellaneous applications are disposed of.

In pursuance to order ibid, dated 9.8.21 passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Manglu Ram TGT (Arts) has filed representation which has been received on 18.9.2021. After bare perusal of the representation we have noticed that the petitioner has mentioned following schools in Mandi Distt. where he has requested for adjustment:-

Since, the petitioner is 45% specially abled candidate and the Hon'ble High Court has directed vide judgement dated 9.8.2021 to consider the representation of the petitioner , hence, the petitioner who has completed normal tenure in GHS Haraboi (MND) working since 6.10.17, is hereby adjusted in GSSS Pourakothi (MND) on his own request without TTA/JT vice Smt Lokeshwari Devi TGT (Arts) with TTA JT.

Accordingly representation stands decided.
