In the matter of: CWP No. 2596/2021 titled as Paramjeet Patyal Vs.  
State of H.P. & Others.

Whereas. Shri Paramjeet Patyal, TGT (NM) preferred the present writ petition against his transfer orders from GSSS Shilla District Shimla to GMS Bhoot (Bali Dhar) u/c GSSS Machoti Distt. Shimla against vacancy, which was listed before the Hon'ble High Court on 22.9.2021 when the Hon'ble High Court has passed the following orders:-

*".....The learned counsel for the petitioner submits that in case the petitioner is considered for being posted against the vacancy which would arise on superannuation of Mr. Surinder Pal Kashyap on 30.9.2021 at GMS Badoo u/c GSSS Gharwasra District Mandi H.P., thereupon he has instructions to withdraw the instant petition. Consequently the respondents concerned are directed to forthwith ensure considering the posting of the writ petitioner at the afore station. Till the respondents consider the posting of the writ petitioner at the station(supra), the post(supra) may not be filled up at the station(supra). The present petition is dismissed as withdrawn. All pending applications stand disposed of accordingly."*

In compliance to the directions of the Hon'ble High Court the petitioner has submitted his representation to the office of the respondent No. 2 i.e. Director of Elementary Education on 24.9.2021 vide which he has requested to adjust him at GMS Badoo u/c GSSS Gharwasra District Mandi against vacancy being caused due to retirement of present incumbent on 30.9.2021.

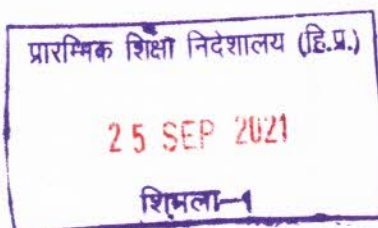
From perusal of record, it has been gathered that the petitioner was working in GSSS Shilla District Shimla since 18.11.2016 and he earlier filed CWP No. 776/2021 titled as Paramjeet Patyal V/S State of H.P. & Others which was disposed of by the Hon'ble High Court on 16.2.2021 with the directions to the State respondents to consider the representation of the petitioner. His representation was decided on 8.4.2021 and he was transferred to GMS Bhoot(Bali Dhar) u/c GSSS Machoti District Shimla. Thereafter, he filed fresh CWP No. 2596/2021 in the Hon'ble High Court against these transfer orders and same has been disposed of on 22.9.2021. At present one post of TGT(NM) is going to be vacant due to retirement of the present incumbent i.e. Shri Surinder Pal, TGT(NM) in GMS Badoo u/c GSSS Gharwasra District Mandi on 30.9.2021. He is hereby adjusted at GMS Badoo u/c GSSS Gharwasra District Mandi against vacancy being caused due to retirement of Shri Surinder Pal, TGT(NM) on 30.9.2021 and directed to join his duties in GMS Badoo u/c GSSS Gharwasra on or after 1.10.2021. The representation of the petitioner is disposed of accordingly.
