Whereas, Sh. Sanjay Kumar, TGT (NM) preferred CWP No. 4957/2021 -titled as Sanjay Kumar Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Daulatpur Chowk District Una to GSSS Kolar District Sirmour vice Shri Anuj Kumar, TGT(NM) & vice-versa. The above writ petition was listed before the Hon'ble High Court Himachal Pradesh on 1.9.2021 when the Hon'ble High Court has passed the following orders:-

".....4 Accordingly, without going into the merits of the case, we direct the respondents to treat this writ petition as representation, and consider the same sympathetically within a period of two weeks from today. Till then status quo be maintained.

5. The petition stands disposed of in the aforesaid terms, so also pending application(s), if any"

In compliance to the directions of the Hon'ble High Court the petitioner was called for personal hearing on 21.9.2021 and he attended the same and requested that he may kindly be adjusted as BRCC at Dadasiba Block District Kangra against vacancy. The petitioner also sought the relief in his writ petition to adjust him as BRCC Dadasiba Block District Kangra against vacancy.

From perusal of record, it has been gathered that the petitioner was transferred from GSSS Daulatpur Chowk District Una to GSSS Kolar District Sirmour vice Shri Anuj Kumar, TGT(NM) vide this Directorate letter of even number dated 28.8.2021 on the completion of his normal tenure of three years at his present place of posting. The petitioner was working in GSSS Daulatpur Chowk District Una since 23.12.2016 and has completed more than three years stay there. The petitioner has appointed as TGT(NM) on 22.11.2008 on contract basis and has posted at GSSS Kaloh (Una) where he remained w.e.f. 22.11.2008 to 22.12.2016. Thereafter, he was transferred to GSSS Daulatpur Chowk (Una) where he joined on 23.12.2016. The cadre of the post of TGT(NM) is State cadre and can be posted/transferred any where in the State. The petitioner has remained in District Una since his first appointment. Accordingly, request of the petitioner can not be acceded to and his representation is hereby rejected. He is further directed to join at the station of his transfer i.e. GSSS Kolar District Sirmour. The representation of the petitioner is disposed of accordingly.
