Allocation of food grains (Rice) for the 3<sup>rd</sup> Quarter (01-10-2021 to 31-12-2021) under the National Programme of Mid Day Meal in Schools (MDMS) for Primary and Upper Primary Schools (Primary 18751.40 quintals & Upper Primary 21557.50 quintals) for the year 2021-22(excluding vacation period).

Sir/Madam,

Literacy, Shastri Bhawan New Delhi-110001, vide their letter No. 5 -1 / 2021 – Desk (MDM)-Part (I) of dated 28 .09.2021 has conveyed the allocation of foodgrains (rice) for Primary Stage ( classes I - V) and Upper Primary Stage (classes VI - VIII) for the 3rd Quarter (01-10-2021 to 31-12-2021) for the financial year 2021-22. Accordingly 18751.40 quintals of foodgrains (rice) for Primary stage and 21557.50 quintals of foodgrains (rice) for Upper Primary stage (excluding vacation period) are being allocated (District wise) on the basis of average beneficiaries of 1st quarter of the year 2021-22 at (ANNEXURE-1). While lifting the food grains (rice), it may be ensured that the best quality food grains (rice), which in any case will not be inferior to Fair Average Quality FAQ, is lifted from the PDS Depot. The process followed at the time of receipt of foodgrains (rice) from FCI Depots may also be repeated at each level till the foodgrains (rice) reach the end user to ensure that only good quality foodgrains (rice) is delivered for consumption by students Records /samples regarding quality assurance should be maintained at all levels.

In view of the above, you are directed to distribute the foodgrains (rice) to the Blocks (excluding vacation period) as per the prescribed norms i.e. 100 gms. per child per day in respect of Primary classes and 150 gms. per child per day for Upper Primary classes be made. In this context, it is further added that the balance of foodgrains (rice) from the previous quarter/ year may be kept in view while allocating foodgrains (rice) to the Blocks for providing Mid Day Meal to the students under MDM Scheme.

Before making allocation (excluding vacation period) the following points may also be considered on priority:-

- · Enrollment / Beneficiary of Block / institution
- Number of school days
- Approved norms 100 gms. Primary classes and 150 gms. for Upper Primary classes per child per day.
- Unutilized foodgrains (rice) lying with the school/ Block.
- (Enrollment/ Beneficiary of Block/ School \* No. of Schools Days in the Quarter/ Month \* approved food norms) - Unutilized foodgrains (rice) lying with the Block/ Schools= Quantity of rice to be allocated to the Block)
- To ensure the timely supply of foodgrains (rice), allocation of rice to Blocks/ Schools should be made on Quarterly basis instead of monthly basis.
- At school level, appropriate record should be maintained and proper receipt should be obtained from the FPS/ PDS holder, indicating the quantity of foodgrains received in respect of their schools and make entries in the MDM registers accordingly.

The information in respect of allocation, lifting, utilization and balance of foodgrains (rice) may be furnished to this office immediately after the closure of the Quarter i.e as on 31-12-2021, so that further necessary action could be taken in this regard accordingly.
