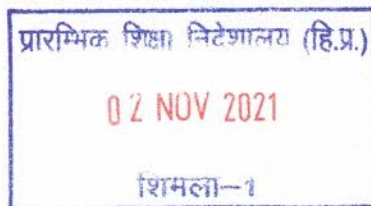

ORDER

In the matter : CWP No. 5098/ 2021- Smt. Seema Kumari, TGT (Med) Vs. State of H.P. & others.

The Petitioner Smt. Seema Kumari filed CWP No. 2221/2021- titled as Seema Kumari, versus State of H.P. & others before the Hon'ble High Court of H.P. regarding her transfer from GSSS, Jhajjakothi, Distt. Chamba , H.P. (which falls under hard area) to her choice of station after completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 06th Sep. 2021 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Accordingly, the instant writ petition is disposed of with a direction to the petitioner to file a representation before the respondents clearly setting out their five station of her choice, out of which one essentially shall be out of her home district. On receipt of such representation, the respondent shall consider and decide the same and thereafter issue consequential orders of transfer within next two weeks. Pending application(s), if any, also stand disposed of."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 29th October, 2021. The petitioner attended the personal hearing on schedule date and time. During personal hearing she requested that she may be adjusted in GSSS, Kot Beja, Distt. Solan against vacancy likely to be caused due to promotion of Sh. Upender Kumar, TGT (Med.) as Headmaster. The petitioner further stated that she is facing some difficulties at the domestic front, hence, she may be posted closer to her home.

On perusal of the record, it reveals that Smt. Seema Kumari, TGT (Med.) is working in GSSS, Jhajjakothi (CBA) since 15-05-2017 which falls in sub cadre area and has completed her normal tenure at present place of posting. Whereas, Sh. Upender Kumar, TGT (Med.) is presently working in GSSS, Kot Beja, Distt. Solan and will be retired from service on 28-02-2022. Moreover, Sh. Upender Kumar, TGT (Med.) is going to be promoted to the post of Headmaster very shortly.

In view of fact narrated hereinabove, Smt. Seema Kumari, TGT (Med.) is hereby adjusted at GSSS, Kot Beja, Distt. Solan, against vacancy likely to be caused due to promotion /retirement of the present incumbent whichever is earlier. Accordingly, representation of the petitioner is considered and disposed of.
