Whereas, Shri Revti Raman, TGT (NM) preferred the present writ petition against his transfer orders from GSSS Govt. High School Kodra District Una to GMS Tranda u/c GSSS Nigulsari, District Kinnaur H.P., which was listed before the Hon'ble High Court on 9.9.2021 when the Hon'ble High Court has passed the following orders:-

".....4. Accordingly, without going into the merits of the case, we deem it proper to permit the petitioner to make a representation within one week from today, which shall positively be considered by the respondents sympathetically within a period of three weeks. It is made clear that this order shall not be treated as precedent in future.

5. The petition stands disposed of in the aforesaid terms, so also pending application(s), if any."

In compliance to the directions of the Hon'ble High Court the petitioner has submitted his representation to the office of respondent No. 2 i.e. Director of Elementary Education on 13.9.2021 vide which he requested to adjust him in District Una against vacancy or longer stay in the stations of Una District stated in the representation on medical grounds.

From perusal of record, it has been gathered that the petitioner was transferred from GHS Kodra District Una to GMS Tranda u/c GSSS Nigulsari District Kinnaur vice Shri Om Prakash TGT(NM) & vice-versa in view of CWP No. 2316/2021 titled as Om Prakash Vs. State of H.P. & Others, on the completion of normal tenure of three years at GHS Kodra District Una as he was working there since 21.04.2016. The petitioner stated in his representation that he is suffering with various heart ailments like Coronary artery disease(CAD), Acute coronary syndrome ACS, anterior wall myocardial infarction(AWMI), Moderate LV dysfunction S/P PCI to LAD and is under treatment at Tagore Hospital & Heart Care Centre Jalandhar, Punjab. Keeping in view of his medical condition respondent department has requested to Chief Medical Officer District Una for his medical examination by Medical Board. The medical condition of the petitioner was examined before the Medical Board on 25.10.2021 and medical report has received in this office on 28.10.2021 vide which it has been found that his health condition is not good and he is advised by the medical board to avoid heavy work and high attitude due to his medical condition. In view of facts narrated above, the petitioner is hereby adjusted on medical ground at GSSS Bangana District Una vice Shri Nand Lal, TGT (NM) who is further transferred to GMS Tranda u/c GSSS Nigulsari District Kinnaur, with TTA/JT, in place of the petitioner. The representation of the petitioner is disposed of accordingly.
