In the matter : CWP No.7428/2021 titled as Sunil Kumar,TGT(Med) Vs State of H.P.& others.

Sh. Sunil Kumar ,TGT(Med) has filed CWP No. 7428/2021 titled as Sunil Kumar,TGT(M) versus State of H.P. before the Hon'ble High Court of H.P. The case of the petitioner was listed before the Hon'ble High Court on 26th Nov.2021, when the same was allowed with the direction to the respondent to transfer the petitioner from his present place of posting i.e. GSSS Railla Distt. Chamba.(which fall under sub cadre area) to his choice of stations.The operative portion of the judgement is as under:

" In this view of the matter,we dispose of this petition with a direction to the respondents-State to consider the case of the petitioner and thereafter consequential order of transfer be passed, positively within a period of two weeks from today."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated ¹⁷⁻¹²⁻²⁰²¹ 23rd October, 2021. The petitioner attended the personal hearing on schedule date and time. During personal hearing he requested that he may be adjusted in GSSS Bhadwar(KGR),SJS GSSS Kot Plahari (KGR) against longer stayee or GHS Indpur u/c GBSSS Indora(KGR) against vacancy being casued due to promotion of present incumbent.The petitioner further stated that he is facing some difficulties at the domestic front, hence, he may be posted closer to his home.

From the perusal of record, it has been noticed that the petitioner is working in GSSS Railla (Sub cadre) Distt. Chamba since 30th August 2018 and has completed his normal tenure at the present place of posting. Hence, the request of the petitioner is considered sympathetically and he is hereby transferred from GSSS Railla Distt. Chamba to GHS Indpur Distt Kangra against vacancy being caused due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent working in GHS Indpur Distt. Kangra.
