ORDER

In the matter : CWP No. 2221/ 2021- Jitender Kumar,TGT(Med) Vs State of H.P.
& others (Regarding transfer).

The Petitioner Sh. Jitender Kumar filed CWP No. 2221/2021 titled as Sh. Jitender Kumar ,TGT (M) versus State of H.P. before the Hon'ble High Court of H.P.regrding his transfer from GHS Chaplandidhar Distt. Mandi,H.P.(which fall under hard area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 06th April 2021 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

“ In view of the same,we do not find any impediment to grant relief to the petitioner .Hence,the petition is allowed and respondent No.2 is directed to consider the representation dated 09-02-2021(Annexure P-3) as expeditiously as possible,in accordance with law”

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated 07th Sep.2021.The petitioner attended the personal hearing on schedule date and time .During personal hearing he has requested that he may be may be adjusted in GHS Fagwao (Sundernagar),GSSS Ropa (Drang-II) or GSSS Kufri (Drang-2) Distt. Mandi against longer stayee and GHS Bahwa(Chachiot-I) or GHS Kalkhar(B.Balh) after functioning of the schools,out of the choice given by him none was from a district other than Mandi.We can give another chance to give option of a school outside Distt. Mandi.The petitioner re-submt representation and requested that he may be adjusted as same station .The petitioner has further stated that he is facing some difficulties at the domestic front, and hence, he may be posted closer to his home.

From the perusal of the record,it reveals that Sh.Jitender Kumar,TGT(Med) working in GHS Chaplandidhar Distt. Mandi 06-09-2021,has completed his normal tenure at present place of posting. Hence keeping in view the family circumstances the petitioner is hereby transferrd from GHS Chaplandidhar (MND),without TTA/JT to GHS Fagwao (Sunder-Nagar) vice Sh. Jai Singh,TGT(Med),with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly
