ORDER

In the matter : **CWP No. 7540/2021-Manju Kumari VS state of H.P. & others(Regarding transfer)**

The Petitioner Smt. Manju Kumari has filed CWP No. 7540/2021 titled as Smt. Manju Kumari, TGT (M) versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GHS Jaral (MND) to GHS Majhagan (MND). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 15th Dec.2021 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"At this stage, learned counsel for respondent No.3 states that since she is wife of Army Personnel, she is entitled to certain benefit under the Comprehensive Guiding Principles-2013 for regulating the transfer of the State Government employees.

Accordingly, we permit respondent No.3 to file representation to the authorities concerned. Needless to say, that the same shall be considered sympathetically and in accordance with the relevant Clause of the guidelines which provides for accomodation to the wives of the Army Personnel. The needful be done within a period of three weeks from today"

As per the order passed by the Hon'ble Court the Respondent No 3 i.e Smt. Indira Devi, TGT(M) made a representation to the undersigned on 17-12-2021 requesting therein for her adjustment against the vacant post at GHS Bhalan (MND) as a Army Personnel wife.

The representation has been examined carefully and it has been revealed that the petitioner has been transferred from from GHS Jaral (MND) to GHS Majhagan (MND) vice Respondent No. 3 i.e. Indira Devi, TGT(M) & vice-versa on the completion of normal tenure of three years as per policy. Now, in compliance to the orders passed by the Hon'ble High Court in aforesaid writ petition the presentation of the respondent No. 3 is considered sympathetically in accordance with the Comprehensive Guiding Principles-2021 and she is hereby adjusted at GHS Bhalan District Mandi against vacancy, without TTA/JT. With these observations the representation of the Respondent No. 3 is considered and disposed of accordingly.
