Whereas, Smt. Usha Devi, TGT (NM) preferred CWP No. 7302/2021-titled as Usha Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from Govt. Sr. Sechondary School Sera District Hamirpur to Govt. Middle School Jani u/c Govt. Sr. Sec. School Ramani District Kinnaur. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 23.11.2021 when the Hon'ble High Court has passed the following orders:-

"...5. Accordingly, the instant petition is disposed of by permitting the petitioner to make a representation, which if made, within a period of one week from today, shall be considered and decided by the respondents within next three weeks thereafter. Till such decision is made by the respondents upon the representation of the petitioner, no coercive steps shall be taken so as to compel the petitioner join at the transferred station. Pending application(s), if any, also stands disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner submitted her representation in this Directorate on 9.12.2021. She was called for personal hearing on 17.12.2021 and she attended the same. She requested that she may kindly be adjusted at GSSS Bharol Kohala (Kangra)/GMS Alsahan u/c GSSS Piploo (Una)/GSSS Bankhandi (Kangra) against vacancy due to her adverse family circumstances.

From perusal of record, it has been found that the petitioner has been transferred from Govt. Sr. Sechondary School Sera District Hamirpur to Govt. Middle School Jani u/c Govt. Sr. Sec. School Ramani District Kinnaur vice Shri Gurnam Singh, TGT(NM) & vice-versa in view of CWP No. 6334/2021-titled as Gurnam Singh, TGT (NM) Vs. State of H.P. & Others vide this office order of even number dated 10.11.2021, on the completion of her normal tenure of three years. At present there is no post of TGT(NM) is lying vacant in the aforesaid schools as mentioned in her representation. Now, the petitioner has given fresh representation in this office vide which she has requested to adjust her at GSSS Manjhol (Kandaghat) District Solan against vacancy, without TTA/JT. Keeping in view of the above position the petitioner is hereby adjusted at GSSS Manjhol (Kandaghat) District Solan against vacancy, without TTA/JT, on her own request. The representation of the petitioner is disposed of accordingly.

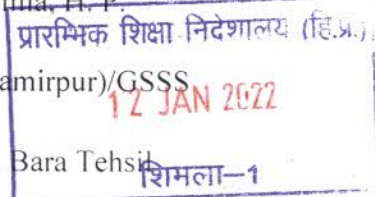

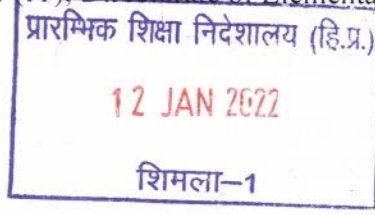
