ORDER

In the matter :

CWP No. 8027/2021 titled as Santosh Kumari,TGT(TGT(Med) Vs State of H.P. & others (Regarding transfer)

The Petitioner Smt. Santosh Kumari,TGT (Med), filed CWP No. 8027/2021 titled as Smt. Santosh Kumari versus State of H.P. before the Hon'ble High Court of H.P.regrding her transfer from GSSS Haripurdhar Distt Sirmour ,H.P.(which fall under hard area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 21st December 2021 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

“ The petitioner has been serving as TGT(Med) in Sub Cadre Area of Haripurdhar, ever since her appointment on 25-08-2018,thus she is entitled to be posted in a soft area of one of the five station of her choice .Accordingly,we deem it appropriate to dispose of the instant petition by permitting the petitioner to file a representation, fairly setting out therein five stations of her choice and one station essentially outside the home District of the petitioner . In the event of receipt of such representation,the same shall be considered,decided and consequential order of transfer be issued by the respondents after three weeks of the receipt of such a representation”

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated.07-01-2022.The petitioner attended the personal hearing on schedule date and time .During personal hearing she has requested that she may be in GHS Lanjyana (HMR),GSSS Pirsaluhi (KGR),GSSS Aluha (KGR),GHS Tip (KGR),against longer stayee.The petitioner has further stated that she is facing some personal difficulties.

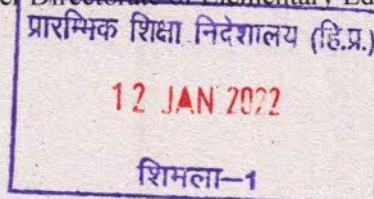
From the perusal of the record, it reveals that Smt.Santosh Kumari,TGT(Med) working in GSSS Haripurdhar Distt. Sirmour since 05th Sep.2018, has completed her normal tenure in sub cadre area. Hence keeping in view the family circumstances the petitioner is hereby transferred from GSSS Haripurdhar Distt. Sirmour to GSSS Aluha Distt. Kangra,without TTA/JT vice Sh. Sanjeev Kumar,TGT(Med),with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly


