- 3) **If the incumbent has already served sub-cadre/hard/tribal/difficult area in that event he/she relieved again to areas ibid.**
- 4) **It must be ensured that the candidate is not specially abled.**
- 5) **It must be ensured that the candidate is not on the verge of retirement.**
- 6) **All provisions as contained in O/M No: PER (AP-3)E(3)17/2021 dated 10.07.2013 "Comprehensive guiding principles 2013 -----for regulating the transfer of State Govt. Employee at point no.5" session to certain categories of employees and 5.5 of O/M dated 17.09.2015 must be adhered strictly.**

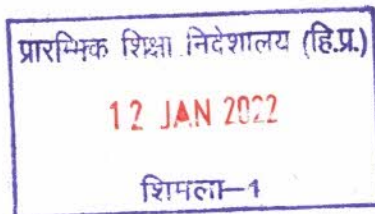
