ORDER

In the matter : CWP No. 8267/2021- Smt. Manju Bala ,TGT(Med) Vs State of H.P. & others (Regarding transfer)

The Petitioner Smt. Manju Bala,TGT(Med),filed CWP No. 8267/2021 titled as Smt. Manju Bala, versus State of H.P. before the Hon'ble High Court of H.P.regrding her transfer from GSSS Kalhel Distt. Chamba,H.P.(which fall under hard area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 28th December 2021 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

Mr.Vikrant Chandel,learned Deputy Advocate Teneral has submitted that the representationmoved by the petitioneris not in consonance with the transferpolicy dated 10-07-2013.

Accordingly,withpout advertng to the merits of the case ,we deem,it appropriate to dispose of the writ petition with liberty to the petitioner to move a feresh representation to respondent No.2 as per the transferpolicy dated 10-07-2013 and e respondent No.2 is directed to dispose of the same within two weeks from the date receipt of the copy of this order.

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 15-02-2022.The petitioner attended the personal hearing on schedule date and time .During personal hearing she has requested that she may be may be adjusted in against vacancy /longer stayee GHS Thandol/GSSS Khaira/GSSS Ballah /GSSS Phara in Distt.Kangra.The petitioner has further stated that she is facing very difficulty to look after her 9 months old baby during school hours.

From the perusal of the record, it reveals that Smt.Manju Bala, TGT(Med) working in GSSS Kalhel Distt. Chamba since 05-09-2018 and has completed her normal tenure at present place of posting. At present there is no post of TGT(Med) lying vacant in the schools mentioned by the petitioner in her representation. Moreover, Sh. Sohan Singh TGT(Med) working in GSSS Khera (KGR) who has completed his normal tenure but he has already served in hard area and Smt.Anupama Thakur TGT(Med) working in GSSS Thandol has also completed normal stay but she has some health problem. Hence, both cannot be transferred vice the petitioner. At present one post of TGT(Med) is lying vacant in GSSS Samnoli Distt. Kangra which is a soft area. Keeping in view the family circumstances the petitioner she is hereby transferred from GSSS Kalhel Distt. Chamba to GSSS Samnoli Distt. Kangra against vacancy.With these observations the representation of the petitioner is considered and disposed of accordingly

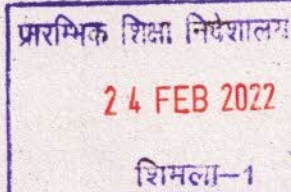
