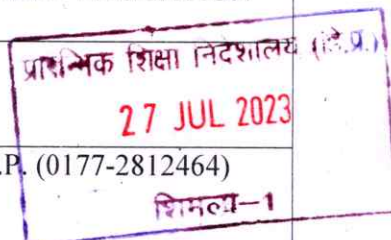

The candidate shall be eligible for appointment, if he/she has passed Matriculation and 10+2 from any school/Institution situated within Himachal Pradesh. Provided this condition is not apply to Bonafide Himachalis.

The Department will also not be responsible or answerable to the candidates or employment exchange for no fault on the part of this Department.</p>

Certified that while placing the demand the instructions concerned with orders on communal representations as also reservation of vacancies for priority candidates of applicants of Ex-servicemen and other reserved categories in terms of revised latest recruitment policy of the state Govt. have strictly been followed with due regard to the roster required to be maintained in accordance with these orders.

Note:-1 Candidature of the married daughter/grand daughter of Ex-servicemen/Freedom Fighter is subject to final outcome of LPA No. 215/2015 titled as Jyoti Kumari and others pending before the Hon'ble High Court of Himachal Pradesh and SLP No. 31435/2016 titled as State of H.P. & Others versus Neelam Kumari pending before the Hon'ble Supreme Court of India.
