Sh. Ashwani Kumar, TGT (NM) preferred CWP No. 1996/2023 titled as Ashwani Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Sharad, U/C GSSS Dharchandna, Distt. Shimla sub cadre to soft area in Distt. Hamirpur / Mandi/ Bilaspur, against vacancy. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 15-05-2023 when the Hon'ble High Court has passed the following orders:-

" 4. In view of above, petitioner is permitted to file representation on or before 31<sup>st</sup> May, 2023 to Principal Secretary (Education) to the Government of Himachal Pradesh and in case such representation is preferred by him, the same shall be considered and decided by said authority on or before 30<sup>th</sup> June, 2023, by passing a speaking and reasoned order, after giving opportunity of personal hearing to the petitioner, if desired so. Order so Passed shall be communicated to the petitioner and in case petitioner is still aggrieved, he will be at liberty to avail appropriate remedy.

**" 5. Till decision of representation preferred by petitioner, at least one of the stations, out of station mentioned in the representation shall not be filled, if not already filled."**

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 18-07-2023. He attended the same and submitted his representation in this office on 18-07-2023. vide which he is serving since 12-06-2015 in GMS Sharad, U/C GSSS Dharchandna, Distt. Shimla sub cadre H.P and he further requested that he may be transferred to soft area in Distt. Hamirpur/Mandi/Bilaspur, against vacancy. He has given five stations of his choice in the aforesaid representation.

From perusal of record, it has been found that the petitioner is working in GMS Sharad, U/C GSSS Dharchandna, Distt. Shimla since 12-06-2015 and has completed more than three years stay at present place of posting. One post of TGT(NM) is lying vacant in GSSS Talyana, Distt. Bilaspur, H.P and (103) students are studying class 6<sup>th</sup> to 10<sup>th</sup> in this school. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred on his own request from GMS Sharad, U/C GSSS Dharchandna, Distt. Shimla sub cadre to GSSS Talyana, Distt. Bilaspur, H.P against vacancy being caused due to promotion of present incumbent as Headmaster. The representation of the petitioner is disposed of accordingly.
