Bilaspur and She further requested that she may be transferred to nearby Distt. Bilaspur, against vacancy. The daughter of the petitioner is having 80% permanent disability of "Locomotor Impaired". She has given five stations of her choice in the aforesaid representation.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Sayar Dobha, U/C GSSS Raniktla, Distt. Bilaspur, w.e.f. 05.06.2021 and has not completed the normal tenure of three years. However, stations of his choice are not vacant at this stage and also there is no person who has completed his normal tenure. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
