She attended the same and submitted her representation in this office on 04-08-2023 vide which She requested that She may be adjusted at nearby Distt. Hamirpur against vacancy.

From perusal of record, it has been found that the petitioner was working as BRCC (Upper Primary) Education Block Hamirpur has repatriated to their present department and further posted at GMS Rod, U/C GSSS Jarol, Distt. Mandi, against vacancy. At present one post of (District Science Supervisor) is lying vacant in Deputy Director Elementary Education, Hamirpur, Distt. Hamirpur. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and She is hereby temporarily adjusted on her own request from BRCC (Upper Primary) Hamirpur, Distt. Hamirpur to Deputy Director Elementary Education, Hamirpur, Distt. Hamirpur against the vacant post of District Science Supervisor, till further orders. The representation of the petitioner is disposed of accordingly.
