ORDER

In the matter : CWP No. 4566/2023 titled as **Ku. Mamta,TGT(Med)Vs State of H.P.& others**

The Petitioner, Ku.Mamta,TGT(Med)) filed CWP No. 4566/2023 titled as, Ku. Mamta, TGT(Med),Vs State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GHS Ananehar Dsitt. Chamba. (which fall under hard area/sub cadre)) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 17th July,2023, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

" Notice before admission.Mr. Navlesh Verma,learned Additional Advocated General,accepts mnotice on behalf of the respondents.

Within four weeks, the respondent shall decide petitioner's representations at 22-04-2023 and 23-05-2023{(Annexure P-2(colly))and communicate his decision to the petitioner."

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated. 08th August,2023.The petitioner attended the personal hearing on scheduled date and time.During personal hearing she has requested that she may be adjusted in GSSS Dhaneta /GSSS Dangri/GSSS Tauni Devi/GHS Nahalwin/GHS ,Kudhar/GSSS Piploo agasint vacancy or longer stay.

From the perusal of the record, it reveals that Ku. Mamta ,TGT(Med), is presently working in GHS Ananehar u/c GSSS Lylh Distt. Chamba (which fall under hard area/sub cadre), since 09th December,2019 and has completed her normal tenure at present place of posting.I find it appropriate to transfer the petitioner to GSSS Dhaneta Distt. Hamirpur against vacancy. With these observations the representation of the petitioner is considered and disposed of accordingly.

In the matter : CWP No.4123 titled as Reena Devi,TGT(Med)Vvs State of H.P. & others

The Petitioner, Smt. Reena Devi ,TGT(Med) filed CWP No. 4123/2023 titled as, Reena Devi, TGT, (Med),versus State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GHS Tarswan u/c GSSS Dharmehar,Distt. Mandi (which fall under hard area/sub cadre) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 27th June,2023, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

"The petitioner has completed her normal tenure of service in the most difficult area having been posted in GHS Trswan u/c GSSS Dharmehar,Tehsil Padhar (Chuhar Ghatti),Dsitt. Mandi since 03-05-2019.In such circumstances ,the petitioner is entitled to be posted to a soft station of her choice in terms of the Comprehensive Guiding Principles-2013.The petitioner has opted for the following five station of her choice ,in para-5 of the instant petition,which are as under:

- i)GHS Reur u/c GSSS Dharampur(Against vacant post)
- ii)GSSS Sarkaghat(MND)
- iii)GSSS Rakoh(MND)
- iv)GHS Binol u/c GSSS Shivabadar(MND)
- v)GSSs Tauni Devi(HMR)

Accordingly ,the instant petition is disposed of with a direction to the respondents to consider the case of the petitioner forher posting to any one of the stations of her choice within a priod of four weeks from today."

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated. 08th August,2023.The petitioner attended the personal hearing on scheduled date and time.During personal hearing she has requested that she may be adjusted in GHS Koon u/c GSSS Kujabalh(MND)/GSSS Sarkaghat/GSSS Rakoh/GSSS Longani/GSSS Tauni Devi Distt. Mandi against vacancy or longer stay.

From the perusal of the record, it reveals that smt. Reena Devi,TGT(Med), is presently working GHS Tarswan u/c GSSS Dharmehar,Distt. Mandi (which fall under hard area/sub cadre)since 03rd May,2019 and has completed her normal at present place of posting. At present one post of TGT(Med)is lying vacant in GHS Koon Distt. Mandi. I find it appropriate to transfer the petitioner to GHS Koon u/c GSSS Kujabalh Distt. Mandi against vacancy.With these observations the representation of the petitioner is considered and disposed of accordingly.
