Whereas, Sh. Ramesh Kumar, TGT (NM) preferred CWP No. 4013/2023 titled as Ramesh Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GHS Fancha, U/C GSSS Ganvi 15/20, Distt. Shimla difficult/hard area to soft area in Distt. Mandi and Distt. Hamirpur, against vacancy. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22-06-2023 when the Hon'ble High Court has passed the following orders:-

*"Accordingly, the instant petition is disposed of with a direction to the respondents to consider the case of the petitioner for his posting to any one of station of his choice within a period of four weeks from today. Pending application, if any, also stands disposed of."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation vide which he has requested that he has completed required tenure at his present place of posting at GHS Fancha, U/C GSSS Ganvi 15/20, Distt. Shimla, H.P and he further requested that he may be transferred to GMS Rosso, U/C GSSS Sadhot, distt. Mandi, GSSS Bhota, GSSS Bohani, Distt. Hamirpur, GSSS Sadhot, GMS Darpa, GSSS Marhi, GSSS Khanot, Distt. Mandi, against vacancy/longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Fancha, U/C GSSS Ganvi 15/20, Distt. Shimla difficult/hard area w.e.f. 27-10-2020 and has almost completed the normal tenure of three years. However, stations of his choice are not vacant at this stage and also there is no person who has completed his normal tenure. Therefore, after careful examination, it is decided that since the Department of Higher Education is going to make promotions to the post of School Lecturer (New) from amongst the eligible Trained Graduate Teachers in near future, hence the petitioner will be given posting at a suitable place as and when the vacancy will arise at his place of choice. The representation of the petitioner is disposed of accordingly.
